Application & Establishment Fees

Application for Enrolment must be made online via the College website. The application fee is \$100.00 and non-refundable.

School Fees

School fees paid per term are due the week before the start of each term. Fees paid annually by 31 January 2026 will receive a 2.0% discount on the *Total Fee*.

Aitken College Building Fund

Notes

Fees include all compulsory excursions/incursions and Sport programs. Year 12 fees are charged over Terms 1, 2 and 3.

Fee Reduction

Families with four or more children attending the College receive a 75% fee reduction for the fourth child and subsequent children.

Late Payments

An administration charge of \$55 per term applies for late payment.

Fee Payment Options 2026

The following options are available for payment of the 2026 school fees:

a) Annual Payment

Pay by 31 January 2026 and receive a 2.0% discount on the Total Fee. Late applications will not be accepted. The annual payment is for school fees and all compulsory activities, including excursions, diaries, yearbook, and other levies.

Please note: Tuition includes compulsory schooling costs but does not include resource materials such as an iPad and apps, booklist items, or school uniform costs. All camp fees, charter bus charges, and other non-compulsory activities (including private music tuition) are still payable on a term basis, due on the dates detailed below.

b) Term Payment

Term fees are due and payable before the start of each term.

For 2026, the due dates are:

- Term 1 Friday 23 January 2026
- Term 2 Friday 17 April 2026
- Term 3 Friday 10 July 2026
- Term 4 Friday 2 October 2026

Please Note: Year 12 fees are charged over Terms 1–3 (Refer to the 2026 Fee Schedule)

c) Installment Method

Aitken College families can pay their school fees via weekly, fortnightly, or monthly plans with Edstart. This is at no cost to families and provides flexible terms, including payment holidays and plan changes at any time. You can access Edstart via www.edstart.com.au/aitkencollege

General Notes

Statements will be issued four times a year payable before the start of each Term. Term 1 statements will be issued in mid-January. Statements for Terms 2–4 will be issued during the last week of the preceding Term.
