Australia has one of the most efficient chicken meat producing and processing industries in the world.

Chicken meat is a hugely popular food with Australians and sees Australian consumers spend approximately \$6.6 billion each year on chicken meat products. Its unique structure creates an industry rich in diverse career, and career progression, opportunities.

There are many different types of jobs offered in this industry, from animal husbandry, agribusiness, science, engineering, quality assurance, laboratory services, marketing, transport and processing to veterinary, nutrition and management positions.

## Further Learning

### Early offers made through UAC

Because UAC has several offer rounds in the first half of the year, many Year 12 students ask us if they can receive an offer now.

The short answer is 'no': the first UAC offers to Year 12 students will be made to [Schools Recommendation Scheme](#) (SRS) applicants on 11 November 2022. Offers made then are not based on HSC results and ATARs. Instead, they are based on other criteria like Year 11 results and the school's rating of the student.

Before November, offers are made to applicants who are not in Year 12 this year and already have a qualification UAC can assess. They're often applying to start a course in Semester 2.

Most UAC offers to Year 12 students are made in late December, after the release of ATARs.

If you're after an early offer, make sure to apply directly to the university of your choice through their early entry program. You can find a full list of early entry programs, including closing and offer dates, in our [Early Entry Guide](#).

### UNSW Law Admission Test (LAT)

If you're a domestic applicant and would like to study the Bachelor of Laws at UNSW, you'll need to sit the Law Admissions Test (LAT). Your LAT score, in addition to your academic results, such as ATAR + adjustment factors, is used in UNSW's selection process.

The 2022 LAT is on Thursday, 29 September 2022. The LAT is offered once per year and results are valid for 2 years. The LAT will be offered at in-person testing venues in Canberra and Sydney, or via remote proctoring.

Register before **5pm AEST 12 August 2022** to avoid paying a late fee.

## Resources

### Consumer Rights for young people in Australia

Before you buy anything, whether it's material goods or a service, you should know:

- your legal rights
- how to protect yourself from scams and other dishonest activities
- what to do, or where to find help, if things go wrong

The older you get and the larger your purchases are, the more important it is that you're on top of how to look after yourself and your investments.



## What is consumer protection law?

Consumer law is there to monitor relationships between individual consumers (you) and businesses selling you goods and services.

Basically, it's in place to prevent people taking advantage and selling you things that don't work, are overpriced, or illegal.

## Who's in charge of consumer protection?

In Australia, the [Australian Competition and Consumer Commission \(ACCC\)](#) are the Government organisation in charge of protecting your consumer rights. They make sure that businesses are doing the right thing. Ensuring that industries are regulated (meaning there are rules they must stick to that make life fairer for everyone), price monitored, and preventing illegal or anti-competitive behaviour.

## What are my rights?

As a consumer in Australia, you can expect:

- To deal with businesses who are honest, reliable, and registered
- Any products that you buy should be [safe](#) and [do the job](#) they're advertised to do
- Get refunds or replacements if you buy items that don't work, are faulty, or never turn up
- Have the law behind you if you need to deal with circumstances where you've been tricked or deceived

## Tips for making safe purchases

There are a lot of dishonest people out there who are more than happy to take or steal your money. You might think that you'll never fall for a scam, but unfortunately it happens all the time to people of all ages.

Bear in mind these tips:

- Banks will **never** ask for your bank details over the phone.
- No reputable business will ask you to pay in [gift cards](#) and if they do, it's a scam.
- If you are making a payment over the phone or online and handing out your card details, you should only have to provide the card number, name on the card, expiry date and [CVC / CVV](#) (card verification code) on the back. You will **never** have to give your bank account number or BSB number.
- Do not sign a contract unless you have read and understood all the term, clauses and small print – they are legally binding

## Check out the seller

Before you buy anything, check that the business selling it is:

- genuine (as in it really does exist)
- registered (with the [Australian Securities and Investments Commission \(ASIC\)](#) register or [ABN lookup](#)), and
- has a good reputation (look at reviews and testimonials from a variety of sources)

Websites like [Scamadviser](#) can be a useful starting point.

## Keep records or proof of purchase

When you buy anything, make sure you get a receipt and keep it. Taking a photo is useful too, as sometimes the ink fades until you can't read it.

If your goods come with a warranty (a type of guarantee from the manufacturer about the condition of the product, repairs, or exchange), or a guarantee (a legally binding assurance of quality) make sure you keep it.

Sometimes you might have to register your item or service, or get a record (even just a stamp) that your warranty/guarantee has been acknowledged or activated. So make sure you do that too.

**Note:** be careful if you buy something online, especially from overseas, as your rights may be different.

### Tips to remember when buying online

- **Never** send your credit card number via email.
- Opt for full payment on delivery, rather than paying the full amount in advance.
- Use gift cards, vouchers, and credit notes as soon as possible so you do not miss the expiry date.
- Never sign up for open-ended charges against your card.
- When you enter your card details, do not provide your bank account number as well.
- Contact your credit card provider immediately if you become aware of an unauthorised transaction on your account (there's usually a number on the back you can call).

### Financial Planners are most in demand in these locations:

Around 24,100 people worked as Financial Planners in Australia in 2021 (source: labourmarketinsights.gov.au). Demand is highest in New South Wales and Victoria. Most Financial Planners work in the Financial and Insurance Services industry.

### How to become a Financial Planner in Australia

To become a Financial Planner, you'll need to complete an accredited degree, undertake a year of training and an exam, and gain registration with the Australian Security and Investments Commission (ASIC).

Step 1 – Complete Year 12 with a focus on English and Maths.

Step 2 – Complete an approved undergraduate qualification, generally a Bachelor of Business majoring in Financial Planning, or Bachelor of Accounting. You can see the full list of approved qualifications [here](#).

Step 3 – Complete a full-time professional year that includes at least 1,500 hours of work activities and 100 hours of structured training (a total of 1,600 hours).

Step 4 – Complete the [Financial Adviser Exam](#) before starting the third quarter of your first professional year.

Step 5 – Register for an [AFS License](#) with the Australian Security and Investments Commission (ASIC).

Step 6 – Complete 40 hours of professional development each year, and comply with the [Code of Ethics](#).

## Frequently Asked Questions (FAQs)

### What do Financial Planners do?

Financial Planners help their clients find the best way to save, invest and spend their money.

### Which industries employ Financial Planners?

Financial Planners are mostly employed in the Financial and Insurance Services industry.

### What options are there for career progression?

There are different kinds of Financial Planning you might like to specialise in, including superannuation, tax planning or debt management.

### Do I need to go to university to become a Financial Planner?

Yes, you will need to study an accredited undergraduate degree, and also meet further requirements and continuing professional development.

### Where do Financial Planners work?

Financial Planners might work for a private firm, or in-house for a business or organisation. They might even work freelance, operating their own small business.

### What are 3 things I can do right now to help me become a Financial Planner?

If you're in high school and you'd like to find out if a career as a Financial Planner is right for you, here's a few things you could do right now:

1. Start working on your maths skills. Create your own budget or try and help the family with theirs, and start researching how investments, taxes and superannuation work.
2. See if you can find work experience in business or finance. This will help you see if you might enjoy the work, and can help you start building important contacts for the future.
3. Talk to a Financial Planner to see what a day in their life is like. If you don't know anyone, see if you can watch videos or documentaries about a career in finance.
