1. Welcome and acknowledgements

Welcome to our Annual Parish Forum for 2023.

2. Report on Parish Pastoral activities throughout 2023 (Agenda - Attachment 1)

Summary of current PPC members and roles, including loss of formers members and gain of new members.

PPC has met 8 times in 2023 - focus has been on drafting a strategic plan for our Parish. The themes and priorities of this 3-year strategic plan are based on feedback we received from parishioner consultations in 2022. Additional forums held in March and August 2023 to gain feedback.

Strategic Plan will be presented today (unchanged from August version) and ask for acceptance by community.

3. PPC presentation of the proposed strategic plan (Agenda - Attachment 2)

Outline vision and mission contained in the 3-year Strategic Plan.

Outline guiding principles from Strategic Plan (related to guiding principles in PPC Constitution).

Outline 3 priorities for the next 3 years (2024-2026) focused on Belonging, Belief and Sustainability.

Summarised outline developed to implement these priorities. Based on developing 3 Parishioner Teams to support current volunteers and provide opportunities for involvement from other parishioners.

Three Sustainability priorities for the coming year: the conduct of a Parish Census, the development of a plan for our properties, and the strengthening of our Safeguarding policies and practices.

Parish Census: Our register of parishioners needs refreshing so that we hold accurate information that will support the pastoral and other activities of the parish. To this end we intend to conduct a census of parishioners in the first half of next year.

Safeguarding: This is a highest priority for our parish. Whilst we are compliant with both Archdiocese and Government regulations, we want to further strengthen our efforts in this area by establishing a Parish Safeguarding Committee.

Parish Properties: Fr Binh has asked a group of parishioners with appropriate skills and experience, and with a good knowledge of the parish, to investigate ways in which the value of the unutilised former convent and surrounding land could be realised. In doing so they were asked to recommend a plan for our properties that would satisfy to some degree the following three objectives.

- · Generate a substantial additional income stream for the parish.
- · Generate one-off additional funds to address a maintenance backlog.
- · Provide for capital works required to facilitate a more welcoming and engaging environment in and around the churches, and if possible, generate the funds necessary for them to be carried out.

The group have commenced their work and at each stage will be liaising closely with the property people at the Archdiocese.

- **2 x Youth** Members (< 25 yo) and **2 x Ordinary** Member (no age restrictions) In addition to these, the two-year terms for existing members, Tony Nicholson and Grace Frazzica, will expire in June next year.

Tony Nicholson - has indicated interest in additional term.

Grace Frazzica – resignation from PPC

Proposal to update PPC Constitution:

Current wording in Parish Pastoral Council Constitution:

4. Membership terms

a) All members may be appointed for terms of two or three years to enable at least a third and no more than a half of membership terms to expire at the same time.

Proposed wording for Consideration (addition of new point b):

4. Membership terms

- a) All members may be appointed for terms of two or three years to enable at least a third and no more than a half of membership terms to expire at the same time.
- b) Terms of membership will commence from January 1 in the year following the Annual Parish Forum in which they were appointed.

Attendees asked to support motion that the terms of existing members be adjusted to expire on December 31st of the final year of their term.

Attendees asked to support motion that the Constitution be updated as above.

Motion Passed: current general PPC members will end first term in Dec 2024. Motion Passed: new PPC members have term begin January 1 in year following AGM. Parish Pastoral Council Constitution updated.

This year we welcomed the 2023 nominated members to the Parish Pastoral Council: JP Eid, Miriam Kruse, Sean Gibson and Marizabel Saliba. We farewelled Grace Frazzica with grateful thanks for her time and contributions to our Parish Pastoral Council. Naween Fernando was nominated to our PPC at the 2023 Forum however due to time commitments resigned from the PPC in April 2024. We thank Naween for his contribution to our Parish community.

This year we also came together as a parish community on July 7 to thank Fr Binh Le for his service and commitment to our Parish. It was touching to see so many people come together to celebrate with Fr Binh and give thanks for his God-given gifts, and the occasion was a testament to the relationships he formed and how he enriched our community during his time here.

On July 10 we welcomed Fr Samuel Kapani to our Parish as our new Parish Administrator. Although he has been in our Parish for less than 6 months Fr Samuel's gentle guidance has provided strength, and we

look forward to continuing to grow as a Parish under his attentive care. We thank Fr Samuel for his openness and support and extend our continued grateful thanks for his service to our community.

Parish Pastoral Council (PPC) Activities in 2024

The focus of the PPC work in its six formal meetings throughout the year has been to begin the work outlined in the strategic plan approved at the 2023 Annual Parish Forum. Some of these initiatives are captured below:

Within **Belonging** we have now introduced welcome packs to provide visitors and new parishioners with some information about our parish. Our monthly "cuppas" after Mass have been hosted by rotating volunteer groups in order to spotlight the work that each group does for our Parish. Our Parish website is now well established and updated weekly with news and events that will assist with provision of information and in spreading the word.

Within **Belief**, the children's liturgy group is going from strength-to-strength through the generous help of our teachers and parishioners. We have also begun plans for Faith Formation events, following the success of the Faith Formation survey and with generous help from some experienced parishioners. We have shared combined School-Parish events for both school feast days as we seek to further strengthen the bond between school and church for our Parish primary schools. Strengthened youth groups with interparish activities have also become regular events providing space for youth to meet other likeminded friends.

Within **Sustainability** we have undertaken a much-needed Parish Census in order to have an up-to-date register of parishioners to inform our pastoral care, strategic planning and resource distribution. We have had regular communication regarding a long-term master plan for our properties enabling us to work alongside the Parish Finance Committee to bring forward the recommendation that we will present at this Annual Parish Forum. We have also begun work to establish a Safeguarding Group for our parish made up of representatives from key groups in order to better fulfill our responsibilities to the vulnerable and youth in our parish. We have continued to strengthen relationships with our local parishes at Williamstown, Altona and Altona North through regular meetings.

We give thanks for the generous donations of goods and contributions of time and service from so many parishioners over the last year. I am so proud to be a part of such a caring, dynamic and faith-filled community. If you would like to become more involved, I would encourage you to reach out and let us know how you would like to contribute – any actions are greatly appreciated.

Attachment 3 - Parish Finance Committee Report to the 2024 Annual Parish Forum

Consistent with the requirements of the archdiocese, the accounting for the parish finances is done on a calendar year basis. To provide a comparison with the full 2023 year and with the 2024 budget, Income and Expenditures have been projected for the full 2024 year based on the actuals for the first nine months, and the anticipated for the last three months.

The full 2024 year result is expected to be a deficit of \$14,600 compared to a budgeted deficit of \$50,500. The following factors contribute to this variation.

- Investment income increased by \$8,100 compared to 2023 and by \$10,400 relative to budget, primarily due to higher interest rates.
- Income from Parishioners has increased by \$4,700 compared to 2023 and by \$3,500 relative to budget, assisted by two one off donations totalling \$6,000.
- Facilities and maintenance expenses are \$20,400 less than budget as all bar urgent works have been postponed pending condition reports on all buildings being completed.
- Unbudgeted consultants' costs of \$10,000, for building condition reports and professional advice concerning options for the former convent, were incurred.

• All other non-staff expenses were below budget but, as expected due to CPI, slightly higher than in 2023.

Current Assets and Liabilities as at September 30th, 2024

Current Assets consist of \$18,500 cash at bank and \$447,500 invested with the Catholic Development Fund.

Current Liabilities consist of Staff Entitlements at \$11,450. There are no Non-Current Liabilities.

Attachment 4 - Appointments to the Parish Pastoral Council
