

Photographing, Filming and Recording students at Ormond Primary School

Annual Consent Form and Collection Notice (OPT OUT)

During the school year there are many occasions and events where staff may photograph, film or record students participating in school activities and events. We do this for many reasons including to celebrate student participation and achievement, showcase learning programs, document camps and excursions, communicate with our parents/carers and school community in newsletters and on Ormond Primary School's social media accounts.

This notice applies to photographs, video or recordings of students that are collected, used and disclosed by the school. We ask that any parents/carers or other members of our school community photographing, filming or recording students at school events (eg concerts, sports events etc) do so in a respectful and safe manner and that any photos, video or recordings ("images" of students are not publicly posted (eg to a social media account) without the permission of the relevant parent/carer.

A. Use or disclosure within the school community

<u>Unless you tell us otherwise below,</u> images of your child may be used by our school within the school community, as described below.

Photographs, video or recordings of students may be used within the school community in any of the following ways:

- in the school's communication, learning and teaching tools (e.g., Compass)
- for display in school classrooms, on noticeboards etc
- to support student's health and wellbeing (e.g., photographs of pencil grip to assist in OT assessments)

B. Use or disclosure in publications/locations that are publicly accessible

<u>Unless you tell us otherwise below</u>, photographs, video or recordings of students may also be used in publications that are accessible to the public, including:

- on the school's website including in the school newsletter which is publicly available on the website
- on the school's social media accounts
- in the school magazine

Your child may be identified by first name only in these images (or not named at all).

We will notify you individually if we are considering using any images of your child for specific advertising or promotional purposes.

Privacy

Photographs, video and recordings of a person that may be capable of identifying the person may constitute a collection of 'personal information' under Victorian privacy law. This means that any images of your child taken by the school may constitute a collection of your child's personal information. The school is part of the Department of Education and Training (the Department). The Department values the privacy of every person and must comply with the *Privacy and Data Protection Act 2014* (Vic) when collecting and managing all
