## Fees and Payment Information

CURIOSITY ELC will be using the online system 'Fully Booked' for invoicing fees. An email with log in details will be sent to you to enter in your child's details, Centrelink and banking details to action after 'Meet & Greet' session.

Payments will be made via Ezidebit which will require credit or debit card details for collecting fees. Please note that there is no CASH or EFTPOS service available for the payment of fees.

It is the families responsibility to ensure that their personal information is correct with Services SA to ensure that the child care subsidy is applied.

### I/we understand that:

- Fees are charged on a fortnightly basis.
- Accounts will be automatically paid via Ezidebit, with the ELC covering the costs of account keeping fees.
- An Ezidebit dishonor fee of \$14.80 will be charged to any transaction that declines and will be reflected on our next fortnightly invoice.
- Fee's are charged for full attendance during term time and days can not be swapped.
- Parents may apply for fee's to be waived, if their child will not be in attendance for **more than two weeks** during the term.
- Accounts are still charged for bookings if my child is absent and for public holidays. Once a child has reached 42 days of absence CCS can only be applied in accordance to the reasons set out in the Childcare Handbook 2023 (p. 41).
- CCS or ACCS is not payable for any session of care that is missed prior to your child's first day with us, or if they do not attend their final enrolled session. Full fees will be charged (p. 34 & 42 of Childcare Handbook 2023).
- I/we must follow the Illness Policy when my/our child is sick and keep them home until their symptoms are no longer presenting.
