# Fees & Levies Payment Options 2026

### **Direct Debit**

The school offers a <u>Weekly, fortnightly or monthly Direct Debit facility</u>. We strongly recommend this option of payment. If you wish to use this facility please indicate this option on the Authority form.

 If you have indicated "Yes" to using the Direct Debit facility, please fill in the attached authority indicating your preference of weekly, fortnightly or monthly payments and calculate your amount by dividing your annual fees by 40 for weekly, 20 for fortnight & 10 for monthly payments.

A confirmation letter & schedule will be sent to you indicating the Direct Debit amount and the date of 1st deduction.

**PLEASE NOTE** – A new Authority Form is required each year for this to continue, Direct Debits are not automatically recommenced.

### **Centrepay**

The school is registered to receive fees via **Centrepay.** Further information and application form can be requested from the school office. Fill in the relevant information and return directly to the School Office. Applications or changes can also be made via your MyGov account directly. Please contact the Office or Centrelink if you require further information.

**PLEASE NOTE** – As per updated Centrelink guidelines a new Application/Authority Form is required each year with a target amount or end date stated. Centrepay is now not continuous.

### **Health Care Card Rebate**

A rebate on school fees is applicable to families with a valid Health Care /Pension Card. Conditions apply. Further information will be made available in the new year.

### **Direct Deposit**
