*** Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's function and objectives. These items are listed below and the amount is a suggested value.

Student Services Contribution

College Council invites each student to pay a student services contribution to subsidise the costs associated with Compass parent/student portal, swimming pool operations, the school mini-bus, maintenance of buildings and grounds

Sporting Equipment and Squad Fund

All monies are used to purchase sports equipment and uniform for all our college teams. E.g., Basketballs, tennis equipment, soccer and footballs, uniforms for our Squads

College Building Fund

All monies are used to fund building projects directed by School Council, for continuous improvements of our facilities

College Wellbeing Fund

All monies are used to fund well-being projects within the College, including the breakfast club

College First Aid Equipment Fund

All monies are used to fund equipment and the maintenance of our First Aid area.

State Schools Relief (tax –deductible)

A not-for-profit organisation that supports the needs of underprivileged Victorian government school students by providing them with new school uniforms, footwear and educational resources during times of vulnerability.

VET Subjects

Students studying a VET subject will have the costs of their VET materials covered by the Victorian Department of Education and Training.

Where parents choose to purchase additional or alternate items from those provided or recommended by the school or provider, they may do so at their own expense. Items to be retained by the student will be required to be purchased independently by the students or their families.

Bus Transport

Students wishing to access a seat on a Department of Education school provided bus must complete an application form annually and parents/guardians must agree to the conditions of travel (available upon confirmation of your seat) and if applicable, the payment of a fare (\$130) per term prior to travel.



Music and Singing Lessons

Payment methods

Via Compass Billing, Bpay, Cash or EFTPOS tendered online or at the general office – receipts will be given. Other arrangements as discussed with the parent.

Refunds

Parent requests for refunds are subject to the discretion of the school and made on a case-by-case basis. Refunds will be provided where the school deems it is reasonable and fair to do so, taking into consideration whether a cost has been incurred, the Department's Parent Payments Policy and Guidance, Financial Help for Families Policy, and any other relevant information. Please note that camps and high costs events will require a medical certificate.

All contributions are made with the knowledge that they are voluntary and once received by the school the funds are allocated to students resources. As such refunds will not be issued.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.

PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:



Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

• Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

 Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
