

# TRANSITIONING FOR YEAR 12 STUDENTS



Some things to remember to be successful in your first year of post secondary studies.

- Attend orientation and transition activities that way you can find out about support and advisory services available to you!
- Seek assistance to learn expectations of lecturers You may have to learn about tertiary essay writing, using sources, avoiding plagiarism, or managing time, etc.
- Remember to ask for help no-one will necessarily be offering any!
- Be an independent learner –lecturers and tutors may not be reminding you about deadlines!
- Take charge of your own learning there might not be anyone checking up to see if you are keeping up with work or assignments!
- Make friends building new friendship groups will help you cope and stay motivated!

### Health and Human Services for Australian Students

#### LOW INCOME HEALTH CARE CARD

Once you have finished school you are no longer a student and you may be eligible for a **Low Income Health Care Card**. This card gives access to a range of concessions, not only on some health care items but also on a range of other goods and services if you are on a low income.

In particular, some TAFE and other short courses offer discounts for cardholders. You may also be eligible for public transport concessions (note that if you are studying interstate you are not eligible for public transport concessions in Victoria).

Eligibility for a Low Income Health Care Card is based on YOUR income over the previous 8 weeks. It is highly recommended that all graduating Year 12 students consider applying for this card.

## Transitioning to work?

#### APPLYING FOR A TAX FILE NUMBER:

It is not compulsory to have a TFN. However, without it:

- Your employer must take 45% of your wages in tax
- Financial institutions are required to tax you interest at 45%
- <u>Centrelink</u> will generally not pay you an allowance such as Youth Allowance, <u>Newstart</u> or <u>Austudy</u>
- You will not be able to defer your higher education fees

**The ATO app:** Lets you access a range of tools and services to help manage your tax and super on the go.

#### **RESUME & INTERVIEW TIPS:**

Here are the four most important ones:

- 1. The elevator pitch a great way to focus your thoughts and create a concise relevant 60 second pitch.
- 2. Active language using powerful, descriptive words that denote ownership.
- 3. Sell yourself craft punchy and dynamic statements.
- 4. Skills and achievements create short powerful sentences to highlight past experiences and achievements.
