G'Day USA Concept

G'Day USA offers Australian students the opportunity to live with an American family for 10 days where they will encounter some of the many cultural differences between our two countries. Travelling as part of a group promotes the importance of team work, respect for others and a greater understanding of being responsible to, and for, other team members in the group.

G'Day USA fosters greater cultural awareness, teaches tolerance for other people and promotes understanding and openness to new ideas.

G'Day USA is generally the first step for young Australians to become true global citizens, opening their minds to the wonders of the world that can be explored through travel. The rapid growth of self-confidence, self-reliance and self-esteem is immediately evident in our young travellers through experiencing the world.

Educational Benefits

Students have the opportunity to develop skills that complement a broad range of curricular areas. Science and mathematical skills such as budgeting and converting between currencies, temperatures and time zones will be experienced first-hand. Knowledge of geography and history is further developed as travellers experience different American cities, museums and historical sites throughout their tour. Students will encounter unique language differences and different meanings for the same words between the two English speaking countries.

Host Family Selection

Our American host families are all volunteers who willingly accept the responsibility of hosting a visitor in their home. EWT generally places one student per family, however, sometimes families may host two or more Australian students. Each traveller is required to write a personal biography complete with a recent photo.

The completed biographies are sent to our Hosting Co-ordinators in America and it is their responsibility to manage the host matching, in conjunction with the American School Coordinator, of the Australian student and the American student and their family. The American student is also required to complete a biography. From the information on both completed biographies the students will be matched, where possible, on the basis of compatibility such as same hobbies, sport, music or interests. The students will also generally be of the same age and same sex where possible. Hosts provide most meals, complete living accommodation and transport to school during hosting. Meals away from the home are at the traveller's expense. One American High school will host the Australian school and all travellers will be staying in the surrounding local area.

The EWT Regional Hosting Co-ordinator is responsible for managing the groups stay at the American school and is available 24/7 during the host period.

* **EWT endeavours to notify host family details by the second week of December.**

Host Locations Available:

- **Seattle, Washington** - famous for its beautiful mountain and ski areas and is only 200 kilometres south of the Canadian border.
- **Portland, Oregon** - built along the banks of the magnificent Columbia River and known for its beautiful forest areas.
- **Sacramento, California** - the Capital City of California which is full of gold rush history and close to snow fields.
- **San Diego, Southern California** - known for its warm climate, beautiful beaches and shares a border with Mexico.
- **Phoenix**, Arizona** - home of the Grand Canyon, one of the natural wonders of the world.

Group Leader Duties

The Group Leader is the focal person for the group and is with the group throughout the entire tour. Group Leaders are required to co-ordinate the details and documents necessary for the tour.

Group Leader responsibilities include:

Preparation of the group for travel;

- Maintaining regular contact with group members prior to departure. To inform parents and travellers of due dates for payments, paperwork etc.
- Organising regular social functions in the lead up to the tour to enable travellers and their families to meet each other, get to know each other and receive tour updates.
- Being available to students at all times during the tour.
- While overseas, liaising with the Regional Hosting Co-ordinator, EWT staff and American host school co-ordinator.

Accompanying the group on all tours and school visits.

- Communicating with traveller's parents or guardians if the need arises.



Itinerary - January School Holidays

DAY 1

Meet your EWT Representative at the airport for check-in. Depart for the United States, cross the Pacific Ocean and International Date Line and arrive in the United States the same day. Transfer by coach to the hotel in Anaheim (Disneyland area) where EWT staff will greet you, assist with hotel check-in and provide your group with information about the area.

DAY 2 Knott's Berry Farm

Once a humble orchard and boysenberry farm, Knott's Berry Farm is now the United States' pre-eminent high-speed thrill park. You'll spin, drop, twirl, twist and turn through gravity-defying rides like The Ghost Rider, The Xcelerator and the Silver Bullet. If you find yourself in need of a break from the excitement, you'll be able to explore your way through the Knott's homestead and the Calico Ghost Town. Try to catch some cowboy antics or a saloon stunt show and spend the day spotting Peanuts characters. Snoopy is always keen to pose for a photo!

DAY 3 San Diego

This morning we travel down the coast to San Diego, "America's Finest City". Enjoy a tour of some of the city's most famous highlights, including Old Town with its rich history amongst the traditional pueblo and Mission-style buildings, before taking an opportunity to pick up some bargains at the Carlsbad Premium Outlets.

DAY 4 Disneyland

Spend the day at "The Happiest Place on Earth": the Home of Walt Disney, Mickey and Minnie Mouse, and all of your favourite Disney characters! Spend the day in the ultimate land of make-believe, exploring the eight themed "lands" and enjoying classic and contemporary rides such as Space Mountain, Thunder Mountain Railway, Indiana Jones, Splash Mountain and Star Wars. Disneyland is, simply put, the measure by which other amusement parks are measured.

DAY 5 Universal Studios

Lights! Camera! Action! Start your day with a tour of the back lot and see where and how movies are made, check out the stunt shows, get spooked at the new Walking Dead Attraction or enjoy the Fast and Furious – Supercharged Ride. And of course, explore the brand-new Wizarding World of Harry Potter featuring Hogwarts Castle, the shops at Hogsmeade and two fun rides! You'll have plenty of time to take in the stunt shows, animal actors, and spectacular rides that make Universal Studios an unparalleled experience. Make sure you bring a camera to the studio. It's hard to say who you might see!

DAYS 6-15 Tour Highlight - Hosting

The highlight of the tour is staying with an American family. By living as part of the family, you will experience the true cultural differences between our respective countries. You will also attend school with your American host as a visitor for one or two days.

Here you will be able to experience what school in America is really like. Your host student may be involved in activities at the school such as football, basketball, and school band or even cheerleading! In addition, there are many other activities to be enjoyed at the school.

Four days of sightseeing in and around your host city and its attractions will be arranged during the week. The coach will pick you up at school in the mornings and return you to the school in the afternoon for you to be able to go home with your American host. All attraction admissions are included for these four days. You will also be able to enjoy quality time over the weekend with your American host family.

DAY 16 San Francisco

Say goodbye to your host school and family and say hello to the City by the Bay! You'll arrive in scenic San Francisco and have the afternoon to explore the city's famous twisting, hilly streets with your fellow travellers and Group Leaders. For dinner, we suggest visiting Fisherman's Wharf area and Pier 39 with the boisterous barking sea lion colony that have made it their home. From there you'll enjoy great views of the bay with Alcatraz and the Golden Gate Bridge in sight and lots of dining options.

DAY 17 Pier 39 & Union Square

Today you'll have a full day to get to know San Francisco. Starting, of course, by the Bay, visit the shops and open-air markets you've seen countless times in the movies. Moving from there to the iconic Union Square Plaza by cable car, you'll walk, trolley and stroll your way through Lombard Street, the crookedest street in the world, exclusive boutiques and old-fashioned restaurants before stopping to take in another great Bay area dinner.

DAY 18 Golden Gate Bridge

You didn't think you could visit California without seeing the Golden Gate Bridge, did you? Of course not! You'll walk across it as part of a city tour through the highlights of San Francisco which may include a drive through Golden Gate Park, up to Twin Peaks for panoramic views of San Francisco, Treasure Island and many other famous San Francisco sites.

Along the way you'll see gorgeous redwood trees, towering skyscrapers and learn more than a little bit of the city's illustrious past. At the end of the day, you'll head to San Francisco International Airport for your return flight to Australia.

DAY 19

In Transit. Cross the Pacific Ocean and International Date Line.

DAY 20

Arrive back into Australia after your amazing trip!

Spending Money

The traveller is responsible for payment of lunch and dinner when staying at hotels. In many cases meals (other than lunch), are provided during hosting. During your hotel stay USD \$200 is adequate to cover the cost of meals and tips.

Group Leaders generally set up a "Travel Fund" which covers optional activities, tipping and meals.

Method of Payment

Initial deposit of \$500 to be paid by cheque or money order to "EWT" or by credit card.

Following the initial deposit of \$500, two periodic payments of \$500 and \$1,000 respectively are required prior to final payment.

After deposit, travellers will receive a receipt for their initial deposit, a welcome letter, BPAY details and dates for subsequent payments.

Final payment is due at the end of the 2nd week in October, approximately 75 days prior to travel.

Insurance

Travel Insurance is mandatory for all EWT travellers. EWT offers a Comprehensive Travel Insurance policy as part of the tour package. The offered insurance provides coverage from 12 months prior to departure.

Complete details of the travel insurance offered by EWT, including the company and their insurance terms and conditions together with coverage amounts is provided to you as a separate document to this application to travel.

The policy includes: Cancellation and Holiday Deferment Costs, Unlimited Medical Coverage, Dental Expenses, Evacuation and Repatriation, Luggage and Personal Effects.

NOTE: Existing Medical Conditions must be disclosed on the EWT Medical Release Form. Any existing conditions should be disclosed to the insurer by the traveller. The insurer will then determine if any additional premiums apply and will advise you directly.

***Travel Insurance can be obtained from an insurance provider of your choice. A copy of your Certificate of Insurance is required by EWT should you decide to obtain insurance from another Travel Insurance provider.

Notes

Tour Cost is based on rates for hotel accommodation, transfers, fares, attractions, etc, including US dollar exchange rate of \$1.00 AUD to \$0.73 USD. Cost is subject to change and the final tour cost is due at the end of the second week in October, approximately 75 days prior to travel.

An initial tour deposit of \$500 is required. Cancellation penalties apply. See Application to Travel document for details.

EWT reserves the right to alter or amend this itinerary at any time.

The Terms and Conditions of partaking in the G'Day USA Program are set out in the Application to Travel / Terms and Conditions Document in this Information and Application Brochure.

The program is available to high school students only from 14 to 18 years of age. Adults may only travel as Group Leaders and must be over 21 years of age and approved by EWT as such.

Application Procedure

THE DUE DATE FOR DEPOSIT IS _____

The documents detailed in the points below are required to be submitted with your deposit.

Please give all documents and your tour deposit payment to your Group Leader, who in turn will collate and forward to EWT. Please note that upon paying the deposit and submitting the Application to Travel and Travel Terms and Conditions Form, you have entered into an agreement (as detailed in the Terms and Conditions Document) with Educational World Travel Pty Ltd (EWT).

1. Application to Travel / Travel Terms and Conditions Document

This document is to be completed by a parent or guardian.

Ensure parent/guardian and a witness has signed this document, otherwise the form will be returned to you for signature(s).

Please carefully read the Application to Travel Form and the Travel Terms and Conditions set out on the reverse side. A copy of the Travel Terms and Conditions is printed on the last page of this booklet for you to retain.

2. \$500 Deposit

Payment can be made by cheque, money order or credit card. If paying by cheque or money order please print your name and group name on the reverse side.

Please attach your cheque/money order or credit card authorisation form to the Application to Travel/Travel Terms and Conditions Document.

Please also complete and detach the Application to Travel/Travel Terms and Conditions and Medical Release form.

3. Medical Release Form

Ensure parent/guardian has signed this document, otherwise the form will be returned to you for signature.

4. Travel Insurance (If applicable)

Travel insurance is automatically included in your tour. If you are not taking the insurance as offered by EWT please tick the 'opt out' box on Page 9.

Travel/Medical insurance is offered by EWT; however, travellers may choose to take out alternative insurance with an insurer of their choice. If you chose to take our alternative insurance you must provide EWT with a current Certificate of Insurance.

The insurance policy provides cover from 12 months prior to departure.

5. Biography Form

This form is used to provide EWT and the American host family with information about the traveller and their parents/families. The form will also require a letter to be completed by the traveller, to be given to their prospective American family. This document will be provided to you electronically 8-9months before your tour departure including instructions on how to complete it and the date it must be returned.

Passport

It is the responsibility of the traveller to obtain their own passport. Application forms are available from all Australian Post Offices or online. It is advisable to allow 6 weeks for passport processing time. If you are not travelling on an Australian Passport it is your responsibility to obtain a valid re-entry permit into Australia, if required.

Health

- Inoculations for travel to the USA are not mandatory but the traveller should see their doctor for professional advice.
- If you are travelling with prescription medication, please ensure it is in its original packaging which shows who the medication was dispensed for and details of the pharmacy dispensing it.
- All existing medical conditions must be disclosed on the EWT Medical Release form.

2. EWT maintains no control over the personnel, equipment or operation of the travel tour, airlines, operators, suppliers or other providers in the itinerary. EWT assumes no responsibility for, and is not liable for any personal or bodily injury, property damage or other loss, accident, delay or inconvenience resulting from but not limited to a wrongful, negligent or unauthorised act or omission by an employee of an operator, provider or supplier; or any wrongful or negligent act or omission by any party not under the control, direction and supervision of EWT.
3. During your trip you should be aware of the risks and dangers associated with various activities in which you may, at your own discretion, participate. Activities such as swimming, snorkelling, diving, boating, surfing, sailing, water skiing, motor scooters, auto rentals, attending clubs and night activities, and any other sporting event or physical exertion, bear certain risks of personal and bodily injury and other risk of loss. Further, you shall indemnify EWT for any costs and expenses of whatsoever nature and including legal expenses incurred by it resulting from your conduct or actions or involvement in any activity whilst on the tour including any damage caused by you to property or bodily injury to another person.
5. EWT acts only as agents for hotels, airlines, bus companies, railway and ferry companies, or other services, and all coupons, exchange orders, receipts, contracts and tickets issued by EWT are issued subject to any and all tariffs, terms and conditions under which any accommodation, transportation or any other services whatsoever are provided by such hotels, airlines, bus companies, railway and ferry companies, or owners or contractors, and by the acceptance of such coupons, exchange orders, receipts, contracts and tickets, the tour member agrees to the foregoing and also agrees that neither EWT nor any affiliate company or subsidiary shall be liable or responsible for any loss, injury or damage to person, property or otherwise in connection with any accommodation, transportation or other services or resulting, directly or indirectly, from acts of God, dangers incident to the sea, breakdown in machinery or equipments, acts of government or other authorities, wars whether declared or not, hostilities, civil disturbances, strikes, riots, thefts, epidemics, quarantines, medical or customs regulations, delays or cancellations of or changes in itinerary or schedules, or from any causes beyond EWT's control, or for any loss or damage resulting from improper passports, visas or other documents, and that EWT shall not be liable or responsible for any additional expense or liability sustained or incurred by the tour members as a result of the foregoing clauses.

(b) If the traveller has not disclosed the information referred to above to EWT then the traveller acknowledges that the failure to do so could result in the traveller being withdrawn from the tour at any time either before departure or during the tour.
(c) EWT shall not be responsible for any medical, dental, hospital, ambulance, pharmaceutical or other treatment expenses incurred by the traveller whilst on the tour and the traveller indemnifies EWT regarding such expenses incurred.
8. EWT reserves the right to alter, amend or cancel any of the arrangements contained in the itineraries.
9. EWT reserves the right to change the tour price or cost without notice due to currency fluctuation, increase in airfare, or accommodation tariffs.
