Scope

This school policy is implemented in line with the Department for Education's <u>Student use of mobile phones and</u> <u>personal devices policy</u>, which applies to all government schools. This document provides direction to students, staff, and families about managing personal devices that students choose to bring to school.

For the purposes of this policy, **personal devices** include mobile phones, smart watches and other digital devices that are capable of sending or receiving messages or calls and/or able to connect to the internet, and personal laptops or iPads that are not owned by the school and have not been brought to school by the student under a separate Bring Your Own Device (BYOD) agreement.

At Greenwith Primary School (GPS) students are permitted to bring a personal device from home, provided they agree to and sign the following Greenwith Primary School Agreements:

- Personal Device User Agreement
- ICT Acceptable Student User Agreement

<u>Definitions</u>: A personal device is a mobile phone and in Years 3 to 6 an approved Chromebook purchased only via the school's portal and under device management.

<u>Smartwatches</u> should not be used as a communication tool during school hours (in place of a mobile phone) and be placed on silent mode with cellular data switched off, or put on flight mode and handed to the teacher for secure storage (as per a mobile phone).

Students are not to be on their phones on school grounds. This includes before school and after school.



Rationale

With the widespread and increasing ownership of mobile phones and other devices among students it is critical that schools, in partnership with families, provide clear guidance for students to become informed, safe, respectful, and responsible digital citizens.

It is the Department for Education's position that access to personal devices during school hours must be managed so that students can be fully present in their learning and in their interactions with their teachers and peers. The aim of this policy is to help promote:

- safe environments with reduced negative impacts of inappropriate use of devices at school, such as cyberbullying, exposure to harmful content, and critical incidents that involve mobile phones
- classroom environments where teachers can teach, and students can learn, free from distractions caused by personal use of devices
- use of breaks as quality time away from screens, encouraging physical activity and play and meaningful face-to-face connections with peers.

Personal devices at school

Students are permitted to bring personal devices to school:

- as a measure to ensure their safety while travelling to and from school
- so that parents and part-time employers can contact them outside of school hours
- so they can be contacted about a person under their own care, where applicable
- to be used during school hours in line with an exemption that has been approved by the school under this policy.

While students are at school, or attending school activities, they must comply with any reasonable directions given by school staff in line with this policy regarding their personal devices.

The Department for Education's policy requires all students at all department schools to keep personal devices 'off and away' between the start and end of each school day, and while they are attending school activities off-site, such as camps and excursions.

Students will not be able to access their personal devices at any time during school hours, unless they have received an approved <u>exemption</u> from the school to use the device for a specific, agreed reason. This means both physical access and remote access (e.g. connecting with the personal device via hotspot or using paired headphones).

The process for contacting your child is via the Front Office. This supports your child in being focused on their learning.

Storage of personal devices at school

Students will turn their devices off or place them in flight mode before putting them away. This includes taking off and storing any wearable technology that fits the definition of this policy, such as smartwatches.

Whilst we understand that some students may need to have a phone or smartwatch on them, it is expected that any student who brings a phone or smartwatch to school will hand it to their teacher at the beginning of the school day and switch off or place them in flight mode, their devices before storing them at the beginning of the school day. They will not be able to access their device until the end of the school day. Class teachers will keep student devices secure within the

classroom for the day and return them to the student at the end of the school day. Students who are at a Specialist subject at the end of the day will need to return to their classroom to collect their device from their classroom teacher.

Responses to non-compliance

Where students use a personal device at school without an approved exemption, or use it inappropriately, a response will be provided in line with the school's behaviour support policy. The following information regards non-compliance:

- Greenwith Primary School would investigate and determine appropriate and logical consequences following our Behaviour Support Policy. In the first instance, students will be verbally reminded to put their personal devices 'off and away' and given to the classroom teacher.
- misuse of personal devices may result in disciplinary action which includes but is not limited to:
 - $\circ \quad$ parents/caregivers contacted, a meeting may be arranged
 - o suspension of IT privileges
 - confiscation of device, which would then be securely stored and returned to parent/guardian at arranged meeting

Students need to be aware that consequences will be applied as per the school's Behaviour Support Policy if any of the above is violated and could include – network lockout, revoke permission to bring the device to school, confiscation of the device, suspension, Police notification etc. Internet activity is recorded and may be used in investigations.

Where a student's misuse of personal devices is serious, it may be necessary for the school to consider responses in line with the department's suspension, exclusion and expulsion of students procedure, or to contact South Australia Police if the behaviour is suspected to be illegal.

Exemptions

Exceptional circumstances

Individual students may have extenuating reasons for needing access to their personal device during school hours, such as where:

- the device is used to monitor or help manage a health condition
- the device is a negotiated adjustment to a learning program for a student with disability or learning difficulties
- the device is used for translation by a student with English as an additional language
- the student has extenuating personal circumstances that require them to have more ready access to their personal device, such as being a parent themselves or a primary carer to a younger sibling or unwell family member.

Please contact the school if you need to request an exemption due to exceptional circumstances. These requests will be considered by the principal (or delegate) on a case-by-case basis. If approved, the exemption will be recorded in the student's file or health care/learning plan as appropriate.

The following temporary exemptions may be made available to students at the discretion of individual teachers. All exemptions are subject to the device being used appropriately and only for the purpose specifically permitted by the teacher. Personal devices must be put '**off and away'** immediately after the exempted activity has concluded, and not brought to future lessons/activities without explicit teacher permission.

- Class teachers may give permission for students (on an individual or whole-class basis) to use personal devices in the classroom for a specified learning activity.
- Individual students can negotiate with their class teachers on an ad-hoc basis if they wish to access a personal device for a non-educational purpose (such as expected contact from a part-time employer or for a wellbeing reason).
- Students may be permitted to bring personal devices on a camp or excursion for learning purposes and/or to
 facilitate contact with their families at specified and supervised times. Expectations regarding student use of devices
 on the camp or excursion will be detailed in parent consent information.

Roles and responsibilities

Principal

- Make sure:
 - The school's policy has been endorsed or ratified by governing council and is clearly communicated and accessible to all students, staff, and families
 - there is a process for regular review of the school's local policy
 - o secure storage is provided for student personal devices that are handed to school staff
 - processes are in place for monitoring internet and school network use by all members of the school community.
- Enforce the policy and responses to instances of non-compliance.
- Consider requests for exemptions from the policy from parents or independent students due to exceptional circumstances on a case-by-case basis. Make sure that approved exemptions in this category are documented and that relevant staff, including temporary relief teachers, are informed about students with an exemption.
- Model appropriate use of mobile phones and support school staff to do the same. Support families to understand the importance of promoting safe, responsible, and respectful use of mobile phones to their children.
- Report and respond to incidents of inappropriate or illegal use of personal devices in line with department policy and procedures and any legal requirements.

GPS reserves the right to collect a device and examine any device, with parental permission, if there is reason to believe that there has been a violation of the policy regarding inappropriate use or content. Students must immediately report any inappropriate behaviour or content to the teacher.

School staff

- Deliver learning opportunities and maintain a safe and productive learning environment. Take steps to minimise distractions from the non-educational use of personal devices in the learning environment.
- Respond to instances of non-compliance in line with the school's policy.



- Report and respond to incidents of inappropriate use of personal devices in line with department policy and procedures and any legal requirements.
- Ensure students who are given permission to access their personal device use it appropriately and only for the specified purpose, and store their personal devices away after the exempted activity has concluded.
- Make sure that any student personal devices handed in for their care are stored in a secure location and are returned to the student (or their parent) by the end of the same school day.
- Model appropriate use of mobile phones and support families to understand the importance of promoting safe, responsible, and respectful use of mobile phones to their children. Use mobile phones for work-related/emergency purposes only when students are under their care.

Students

- Comply with the requirements of this policy and follow all reasonable directions from the principal and school staff.
- Switch all personal devices off, or into flight mode, on arrival at school each day and store it away as specified in this
 policy. Mobile Phones and other devices are to be kept securely in bags upon entering and exiting the school
 grounds. They are to be handed to the teacher at the start of the school day for safe and secure storage throughout
 the day and returned to students at the end of the day.
- If permitted to use a mobile phone or personal device in line with an exemption under this policy, do so in a safe, responsible, and respectful way and support peers to do the same.
- Communicate respectfully with others and do not use a mobile phone or other personal device to bully, harass, or threaten another person.
- Students will not share their personal devices with other students. Only the student that brings the device may use the device. Personal login details will be kept secure.
- Respect others' rights to privacy and do not take photos, film, or audio records of other people without their knowledge or permission.
- Notify a school staff member as soon as possible if feeling unwell or experiencing any other issues at school. Use the school's sign-out processes in all cases where requiring early collection from school.
- Comply with the requirements of the school's Personal Device User Agreement and ICT Acceptable Student User Agreement and follow all reasonable directions from the Principal and school staff.
- Students are not permitted to bypass or hack into any hardware or software systems. No personal information about self or others is to be revealed.

Parents

- Support the school's implementation of this policy, including the consequences for non-compliance.
- Encourage their child not to bring a personal device to school unless necessary. Understand that the department does not provide insurance for accidental loss or damage to personal property that is brought onto school grounds

- (however, claims may be met under the department's public liability insurance where the loss or damage can be attributed to a negligent act or omission on the part of the school the school will contact the department for advice if this may be the case).
- Use the school's formal communication channels in all instances to communicate with the school or to make contact with their child during school hours (including where a student requires early collection from school). Encourage their child to always report to a school staff member in the first instance if they become unwell or experience an issue at school.
- Recognise the important role they play in supporting their child to use their mobile phone (or other personal device) in a safe, responsible, and respectful way.
- Chromebooks are **ONLY** to be purchased via the School portal and under device management by GPS IT.
