Dear Parents and Carers of MVIMP students,

We write to inform you that MVIMP musical tuition lessons will continue to be delivered remotely for the duration of Term 4. It was recommended to continue delivery remotely to ensure the safety of all. When students in Year 3 to 6 return to face to face teaching the MVIMP music tuition lessons will be facilitated with your child/ren being supervised by a staff member onsite whilst the lesson is delivered remotely from their Music Tutor.

We invite your child/ren to participate in the virtual delivery of the MVIMP program during Term 4.

This is a wonderful opportunity to continue your child/ren's musical study and our MVIMP Music Tutors have reported very positive feedback regarding the improved musical skill and confidence of the students who have participated in the 'Remote Lessons' during Terms 2 and 3.

The MVIMP Program will also provide virtual performance opportunities for students in Term 4 to replace the Combined Concert which cannot be offered this year. The Tutors will spend time in Term 4 producing promotional videos that showcase the MVIMP Program for future years. We are seeking your permission for your child/ren to be filmed for these purposes and ask that you provide your permission below.

As in Terms 2 and 3 the arrangements for the remote delivery of MVIMP lessons are:

- MVIMP lessons will be delivered via Webex (the use of this platform is supported by the Department of Education and was used during Term 2 and 3)
- The remote lessons for Term 4 are again offered to our existing MVIMP students at a **discounted** rate of 20%. If families should require any financial assistance at this time, please contact your school's MVIMP Co-ordinator. This opportunity will continue both student learning, connection with their tutor and provide financial support to our MVIMP families
- A nominated parent email will be provided to our Music Tutors in line with our privacy obligations. This will facilitate the delivery of the lesson to your child/ren
- Lessons will be delivered as a group lesson delivered by your child/ren's regular MVIMP tutor
- Your child/ren's Music Tutor will email parents/carers and with an invitation to the lesson, this is a parent approved process. In accordance with DET's privacy guidelines please do not share this information with anyone.
- Lessons will be delivered in accordance with our Child Safe Standards and obligations.
