Finding an Authorised Witness

Persons who can witness documents in Victoria are listed below. It is always best to telephone first to arrange a convenient time in case they are not available. In the evening, often the easiest person to contact is a Justice of the Peace. Lists of these are usually kept by your local Council. The Justices of the Peace Registry also provides a Recorded Information Line for the public who require the services of a JP, in any locality of Victoria. - · A legally qualified medical practitioner

- A member of the Institute of Chartered Accountants in Australia or the Australian Society of Accountants or the National Institute of Accountants
- The secretary of a building society
