EQUIPMENT REQUIREMENTS:

Tuition and consumable resource fees for VETDSS students are fully funded by the Department of Training and Workforce Development (DTWD), meaning there is no cost to the student.

However, students are required to purchase a Salon Assistant Equipment Kit to participate in the course. This professional kit includes the essential tools needed for practical training and is not covered by DTWD funding.

All students accepted into the VETDSS training program at Taylorweir **must purchase this kit**. The kit remains the property of the student, and any lost or damaged items must be replaced at the student's own expense.

Cost of the Equipment Kit: \$395.00

- A \$100.00 deposit is payable upon acceptance into the course.
- The remaining balance of \$295.00 must be paid in full by 12 January 2026.

Please note: Full payment of the equipment kit confirms the student's enrolment in the Certificate II in Salon Assistant course.

UNIFORM REQUIREMENTS:
