Parents are advised via Compass and learning overviews, of Extra-Curricular Items and Activities payments (e.g. excursions, incursions, camps, interschool sporting events, grade 6 customised jacket, student lead conference) as they arise throughout the year.

Educational items for students to own – covers items directly related to delivering the curriculum.

Education items directly related to delivering the curriculum (learning resources) for students to own (e.g. student booklists). These items are supplied via a 3rd party supplier, agreed upon by school council. In 2022 our 3rd party supplier is Winc. Information regarding the purchasing of these will be distributed via Compass as they arise.



Financial Support for Families

Roxburgh Homestead Primary School understands that some families may experience financial difficulty and offers a range of support options, including:

The Camps, Sports and Excursions Fund (CSEF) provides payments for eligible students to attend activities like:

- school camps or trips
- school-organised extracurricular swimming and school-organised sports programs
- outdoor education programs
- excursions and incursions.

Families holding a valid means-tested concession card or temporary foster parents are eligible to apply. A Special Consideration category also exists. Schools can receive applications from families over terms one and two. Families can list more than one student in the one application form if they are attending the same school. FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.

PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:



Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for noncurriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

 Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

 Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
