The Child Support Legal Service of Victoria Legal Aid (VLA) assists parents with legal problems relating to:

- getting or paying child support
- parentage testing
- changes of child support assessment
- spousal maintenance
- adult child "over 18" maintenance.

Free confidential appointments are available for eligible people at VLA offices and regional centres, and by telephone or video conference.

The Child Support Legal Service is independent from the Department of Human Services (Centrelink and Child Support).
