Applications:

Are invited from the LCS community. Students, parents, staff or those with other links to the school will receive priority when stall spaces are allocated. If space allows, and/or insufficient applications are received from the LCS community, applications will be accepted from outside the school. These will be carefully assessed before acceptance.

Closing Date:

Applications must be received by September 27th

Cost of Stalls:

Stall holders will donate 20% of their sales to PandF, or \$25, whichever is greater.

Donated Items:

If you love to make things but don't want a whole stall to yourself, we want to hear from you! Alongside the stalls run by stallholders, there will be a table for donated handmade items which we would love to fill with any amazing goodies you can make. The stall of donated items will be staffed using a roster of parents (as is the rest of the fair), but stallholders running individual stalls will be required to staff their own stalls.

TERMS and CONDITIONS: Launceston Christian School Handmade Market 2019

By applying for the LCS Handmade Market, you understand and agree with the following:

1. Your application is NOT immediate acceptance, and the selection team reserves the right to decline any application.
2. Stall-holders may have the opportunity to be placed on a waiting list if they are unable to be accommodated during first round offers. Being on the waiting list is optional, and there is no assurance made that these stall-holders will be offered a space at the market.
3. Please understand that some types of products (particularly jewellery) tend to be over-represented. If this situation occurs, to allow as many stall-holders as possible to still participate, the selection team reserves the right to offer smaller stalls to those stall-holders selling over-represented product types.
4. You will be advised via email if your application has been accepted. You must respond with your acceptance email (via email or text) within 14 days or your place will be allocated to another applicant.
5. All product for sale must be handmade. No commercially made or second hand items.
6. No food items are to be sold as part of the handmade market.
7. Stall set up time will be announced closer to the Fair, but is likely to be between 3.30pm and 4.45pm on Friday 8 November 2019. No access will be available prior to this time, and stalls must be set up and ready by 4.45pm.
8. Stall spaces will be of a size to accommodate a standard trestle table (unless otherwise noted, as in point 3 above). Stall-holders are encouraged to be creative with their display. You must inform the market co-ordinator if you wish to use a rack or other display in addition to the table, and use will only be permitted if space allows.
9. Stall-holders may share a space. If sharing a stall, applications must be submitted together.
10. Stall-holders must provide their own table, float, packaging and everything else they need to conduct business.
11. All floats, eftpos facilities, and other valuables are the stallholders' responsibility. Launceston Christian School, or any of its representatives, will not be held responsible for any loss or damage to person, money or property, however caused, including the negligence of the market or its representatives or agents including loss or damage arising from weather issues or cancellation of the event.
12. The market and its stallholders/businesses will be promoted via the LCS facebook page and the Herald. Any photos submitted as part of applications may be used in this marketing. The LCS market team reserves the right to select images but makes no representation to include any or all images provided.
13. Stallholders are encouraged to promote the LCS handmade market to the wider community via word of mouth and social media as appropriate (eg: Facebook, Instagram, website, blog etc.)
14. The LCS handmade market will be run as part of an event held at a Christian school, and, as such, will represent the same Christ-centred values as are embodied in the rest of the school. No applications will be considered if items to be sold or the stallholder/s are considered to display concepts which may contravene Christian principles.
