



Student Driving to School Agreement

This form must be completed by any student who intends to drive to school either occasionally or regularly.

If the student intends to drive any car/vehicle other than that registered on this form, it must also be registered with the school.

School Requirements:

Please note: Students are not permitted to carry other students as passengers to and from school and are not permitted to park on the school premises.

1. Students are required to adhere to all road rules and drive in a safe and responsible manner.
2. Students are only to use their car for travelling to and from school. Students are not permitted under any circumstances to drive from the school grounds during the day.
3. Car make, registration and license details must be recorded with the school.
4. It is expected that all students attending organised school events are to travel with the supervising teacher and other students on the arranged transport.

Students who fail to meet these obligations will be required to hand their car keys to a Principal class member or Year Level Leader. Any unsafe driving behaviour or breaches of road rules will be reported to the police.

Dear Parent/Guardian,

Parent/Guardian of Student Drivers

The school is aware that a number of senior students intend to drive to school either occasionally or on a regular basis.

Students and parents need to be aware that students cannot park in the school grounds and that they are not permitted to go to their car during the school day. It is also important that students and parents are aware that under no circumstances can students, once at school, transport other students in their cars when travelling to and from any school program or function.

Other school expectations are detailed in the attached copy of the ***School Council policy on Student's driving to School***. Breaches of the school policy will lead to appropriate disciplinary action.

The school is mindful of the fact that young drivers are at greater risk than older more experienced drivers and that travelling with teenage passengers considerably increases the risks for young drivers. Consequently, we are conscious of the need to ensure a duty of care for our students.

We are also committed to ensuring that the community maintains a positive perception of the school and that irresponsible and unsafe driving by students will inevitably have a negative effect on the school's image within the community. We therefore have an expectation that students will drive to and from school in a safe and responsible manner. If the school becomes aware that students are breaking road rules, the police will be notified.

Please note that the ***Student Driving to School Agreement*** must be signed and completed before driving to school may commence.
