# **CSEF Information**

The college would like to ensure that we have taken into account your student's eligibility for the camps, sports and excursion funding (CSEF) for 2016. The CSEF funding will partially cover the cost of the planned Year 8 2017 camp which costs \$285.00

School **camps** provide children with inspiring experiences in the great outdoors, **excursions** encourage a deeper understanding of how the world works and **sports** teach teamwork, discipline and leadership. All are part of a healthy curriculum.

CSEF is provided by the Victorian Government to assist eligible families to cover the costs of school trips, camps and sporting activities.

If you hold a valid means-tested concession card or are a temporary foster parent, you may be eligible for CSEF. The allowance will be paid to the school to use towards expenses relating to camps, excursions, or sporting activities for the benefit of your child.

The annual CSEF amount per student is: \$225 for secondary school students.

## **Eligibility date**

CSEF eligibility will be subject to the parent/legal guardian's concession card successfully validating with Centrelink on either the first day of term two (11 April 2017) or term three (13 July 2017).

#### **Validation Dates**

- If the parent/legal guardian's concession card successfully validates on the first day of term two (9 April 2017), the application will be processed and the full annual payment will be made to the school from the commencement of term three.
- For applications which fail the term two validation, but become valid on the first day of term three (14 July 2017), the application will be processed and payment will be made to the school during term three.
- If your application does not meet both validations, please note that you will be responsible for making the full contribution for your student's camp cost of \$285.00
