

The Catholic Social Teaching principle of Dignity of the human Person is transformative in today's society. Guided by this principle, the encyclicals and teachings of the Bible, Caritas works to ensure all people are treated with respect. Caritas shares the mission of the Catholic Church to serve the poor and promote charity and justice throughout the world, by restoring the faith and dignity of underdeveloped communities. Human Dignity is the principle that all people should be treated with equal respect and sacredness as they are all created in the image of God, and have a unique life calling. Caritas is guided by these principles to create lasting change in vulnerable communities.

As a woman in the Democratic Republic of the Congo (DRC), Irene lacked both physical and financial support. After the death of her father in the war, Irene's family was displaced, leaving her mother as the sole provider of the family. Despite these hardships, Irene was able to attend school for a time, but her education was cut short when she became pregnant as a teenager and had to drop out. When the father of her child abandoned her, Irene was left isolated and forced to rely on her mother's limited income to support her and her child. Irene shared, "I suffered with my child alone: none of his family members helped me" (Caritas, 2025). This reflects the seclusion forced upon her at a very young age. Irene's lack of education restricted job opportunities, further complicating her ability to provide for her family. Irene's experience highlights the harsh injustices faced by women in the DRC, where conflict, poverty and gender inequality severely limit opportunities. Irene encountered challenges, including limited access to education and employment, economic hardships and inadequate healthcare. Like countless other women, Irene was trapped in a cycle of poverty and dependence, shaped by the injustice she endured.

The encyclicals and teachings of the Bible empower organisations to take action and help communities struggling with poverty. Guided by the Catholic Social Teaching principle of Dignity of the Human Person, Caritas and other organisations work to reduce poverty and restore dignity in individuals. As affirmed by Pope Francis in the encyclical, *Fratelli Tutti*, 'every human being has the right to live with dignity and develop integrally: this fundamental right cannot be denied by any country'. (Francis, 2020, sec. 107). This demonstrates the importance of upholding the dignity of all people. Encyclicals are a moral foundation for organisations, encouraging them to address poverty and collaborate to build a better future for all, but especially disadvantaged communities. Bible teachings act as a guiding compass for Caritas, inspiring them to make change, as written in 1 John 3:17, 'but to anyone who has the world's goods and sees his brother in need, yet closes his heart against him how does God's love abide in him?' This demonstrates that human dignity stems from God's love and guides individuals to help others. By encompassing the teachings of the Bible and encyclicals, organisations like Caritas are guided to transform struggling communities.

Through the support of organisations, disadvantaged communities are able to achieve independence and build brighter futures. Caritas provided Irene with a six-month sewing program, where she and her peers learnt essential skills and received sewing machines, prompting them to start their own businesses. This training allowed Irene to become financially independent and able to provide for her family. As Irene described, "before, women depended on men's incomes, but now, with our new sewing skills, we can take care of ourselves." (Caritas, 2025). Inspired by the compassion of Caritas, Irene began mentoring other women in her community for free, just as Caritas had done for her. Today, these women make and sell garments that generate enough profit to put food on their tables and send their children to school, no longer having to rely on anyone else. This demonstrates the lasting impact that

Caritas has had on this community. Irene's story mirrors the parable of the Good Samaritan (Luke 10:27-35), where true compassion is shown by the one who does not hesitate to help a neighbour in need. Just as the Good Samaritan had shown mercy to the wounded man, Caritas responds to the suffering of vulnerable communities by providing immediate aid and restoring hope and dignity. Through Caritas, Irene's community has been able to thrive, providing both financial independence and purpose.

The Catholic Social Teaching principle of Human Dignity has lead organisations to transform disadvantaged communities. This compelling example of Irene in the DRC demonstrates how Caritas has created lasting change and has restored dignity and purpose to women in the DRC.
