# June 30 is the end of the financial year, so what does this mean?

AFTER JUNE 30, AND IF YOU HAVE EARNED MONEY AND PAID TAXES YOU ARE REQUIRED TO LODGE A TAX RETURN. A TAX RETURN IS A SERIES OF FORMS THAT YOU FILL OUT TO SHOW THE AUSTRALIAN TAXATION OFFICE HOW MUCH MONEY YOU EARNED AND HOW MUCH YOU PAID IN TAXES DURING THE YEAR. THE ATO WILL THEN WORK OUT IF YOU HAVE PAID ENOUGH OR TOO MUCH AND EITHER ASK YOU TO PAY MORE OR REFUND YOU.

## July One to June 30 is a Financial Year

Tax is deductible from your earnings once you earn over \$18,200 a year, this equates to around \$350 a week.

Tax goes towards supporting essential services in our communities:

- Schools and education
- Hospitals and healthcare, such as Medicare
- Roads and infrastructure
- Emergency services, like fire services, ambulances, and police.

A Tax File Number is a unique number for taxation purposes, and everyone working in Australia needs a one.

If you need a TFN, Leanne can start the process at school and it can be completed at Australia Post with a parent/carer.

A PAYG Payment Summary is issued by your employer at the EOFY. A PAYG payment summary details your payments and tax withheld.

You can access your PAYG payment summary from your MYGOV account.

You will need to provide your TFN to an employer, your supperannuation provider, your bank and other government departments.

**TFN:** Tax File Number - Unique number that you apply for **ATO:** Australian Taxation Office - Government department **PAYG:** Pay As You Go payment summary - used to lodge your Tax Return - payment & deductions during the financial year **EOFY:** End Of Financial Year - July to June

#### Tasks

#### Qualifications

You need a Certificate III in Early Childhood Education and Care to work as a Child Care Worker, TAFE's deliver this qualification. Other qualifications may include; Working with Childrens Check. First Aid with CPR, Asthma and Anaphylaxis, and Food Handling certificate.

#### Roles in a Center

Childcare centers require more than just early childhood educators! They also need cleaners, administrators, assistant educators, directors, and kitchen staff
