



# OUR HOLY REDEEMER SCHOOL

Dear Parents,

I wish to provide you with the following information in relation to 2025 Tuition Fees and Charges and thank you for your cooperation and continued support of the school.

According to the 2025 budget parameter set by Melbourne Archdiocese of Catholic Schools (MACS), schools are required to establish tuition fees in line with the current government funding model by meeting the CTC (Capacity to Contribute) to be financially sustainable. To explain, CTC is a measure of a school's ability to recover tuition fees and is based on the Direct Measure of Income (DMI) score of the school. Grant funding per student is adjusted down by the CTC amount.

Our Holy Redeemer aims to ensure that the school can continue providing a high-quality education for all students as well as protecting the financial sustainability of the school. This has resulted in an average increase in the Family Fee and Student Composite Levy of 5%, Maintenance Levy of 3%, and the Capital Levy remains unchanged for 2025.

Following on from consultation with our MACS Finance Business Partner and the School Advisory Council, we have finalised our Fee Structure for 2025 as detailed below.
