This includes ALL books/pens/pencils/paper etc, art supplies, online programs, classroom materials, sporting programs inc. buses. Parents will not be requested to make any financial contribution to cover these items.

The only requested payments will be for camps and any other extra-curriculum excursions. These items will be parent choice in terms of student attendance.

There has been a number of complex contributing factors that has enabled us to achieve and provide this for our families.

Extra-Curricular Items and Activities

Torquay Coast Primary School offers a range of items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides in order to deliver the Curriculum. **These are provided on a user-pays basis.**

Individual Excursions or Camps will be organised throughout the school year. Events will be placed on COMPASS for online Consent and payment via COMPASSPAY or BPAY. Payments for these items are required before your student attends.

We have given an indication below of what possible extra-curricular activities your student may have the option of attending.

Payment Methods

We are a CASHLESS SCHOOL - Payments can be made via BPAY or COMPASS PAY.

Refunds

Full refund shall be payable to the student when:

 No cost is incurred by Torquay Coast Primary School, provided that Torquay Coast Primary School deems the student's withdrawal was unavoidable e.g. illness (a medical certificate may be requested).

Partial refund shall be payable to the student withdrawing when:

• The student's withdrawal has incurred non-refundable expenses relating to the withdrawal e.g. bus costs or prepaid entry fees. In such cases, the refund will be the amount paid by the student, less the expenses incurred by Torquay Coast Primary School as a result of the withdrawal.

No refund will be payable to the student withdrawing when:

- Torquay Coast Primary School has incurred the full costs of the camp or excursion.
- The principal will have the capacity to view special circumstances on an individual basis. This decision will be binding.

Refunds will only be considered when requesting in writing within 21 days of the excursion taking place or the commencement of the camp.

Where Torquay Coast Primary School makes the decision to cancel a camp or excursion, the amount paid by the student shall be refunded in full. Where a camp or excursion has to be rescheduled because of Government or DET warnings/advice e.g. fire or weather danger etc. parents may request a refund of monies paid by them less any funds incurred by the school for the rescheduled trip.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.

PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:



Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

• Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

 Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
