#### 2026 Annual Tuition Fee

I am writing to provide you details of changes in tuition fees for the 2026 academic year.

Any decision to adjust tuition fees is never made lightly, nor without careful and thorough consideration of our students' needs and our school's capacity to provide an education experience that supports every student to flourish. We are also cognisant of the financial pressures that many families have experienced this year.

The cost of operating our school is increasing in multiple areas including wages, insurance premiums, regulatory and compliance costs, risk management, teacher resources and professional learning.

Our tuition fees at St Peter's School are also influenced by the Commonwealth Department of Education's calculation of our community's ability to financially contribute to the operating costs of our school, known as the Capacity to Contribute, or CTC, which is reviewed annually.

To ensure that we can continue to deliver a personalised, high-quality education that is responsive to the diverse interests and academic, social and emotional needs of our students, it is necessary to adjust our fees in 2026.

Please find attached the Fee Schedule for 2026.

If you have any questions or concerns regarding the fee increase, or wish to discuss your individual circumstances, please do not hesitate to contact me. We remain committed to keeping tuition fees as low and affordable as possible, and to working closely with our community to make this transition as smooth as possible.

The above School Fees and Levies include **ALL** excursions/incursion, sports, library, and subject costs. We are strongly encouraging families to set up a direct debit payment as this helps families manage their financial commitments but also reduces the administrative burden in our office. To assist us with the setup for this process, we are asking families to elect their payment preference on the Direct Debit Authority Form and **return to the office by 28<sup>th</sup> November 2025**.

School Fees Statement will be sent to you by the end of February 2026.

#### **Concessional Fees**

If you are the holder of a Health Care Card (HCC), concessional fees may apply. At the beginning of 2026 we will ask for copies of HCC to be provided so concessional fees can be applied.

Fees and Levies can be paid in full or in instalments as shown below, *this is a guide only for one child:*Yearly Fees Foundation – Yr2: \$2,715 Yr3 & Yr4: \$3,085 Yr5 & Yr6: \$3,690

## Payment Options:

One off Annual Payment OR Termly Payments (4 Instalments) OR Monthly Payments (8 Instalments) OR Fortnightly Payments (16 Instalments)

### **Payment Due Dates:**

One off Annual Payment – 15 March 2026

**Termly Payments** – 4 equal Instalments Due on 1 March 2026, 1 June 2026, 1 September 2026, 1 November 2026

Monthly Payments - 8 equal Installments commencing on 15 March 2026 - and ending on 15 October 2026

Fortnightly Payments – 16 equal Instalments commencing on 15 March 2026 ending on 15 October 2026
