#### Work Experience with National Pharmacies

## How to prepare for job interviews (with Virtual Reality)

There's nothing more nerve-wracking than your first job interview. Even practising for job interviews with teachers, advisors, or your school can be anxiety-inducing. Here are a few tips on how to prepare so you can ace your next job interview.

## 6 steps to prepare for job interviews

As a student there are a few essential things to understand and get comfortable with to prepare yourself for job interviews:

- 1. **Plan your travel** Prior to your interview map out how long it will take to get to the workplace and how you will travel to make sure you're punctual and on time. It's important to know what time you need to leave to arrive before your interview time.
- 2. Choose an appropriate outfit what you wear communicates how you present yourself. Choose clean clothes that are suitable for the workplace you're interviewing at. This depends on the workplace. You must dress accordingly if it's a corporate office, a retail store, cafe, recreation centre or other workplaces. Dress to impress, and match your clothing choices to the workplace.
- 3. **Greet everyone with a smile** when you arrive at a worksite, often you will greet another team member, a receptionist or other employee before the person interviewing you (which is usually HR or a hiring manager). It's important to make a good impression on everyone you interact with at the workplace. Often your interviewer will ask everyone you spoke to how you interacted with them. If you leave a bad impression, that can impact your chances!
- 4. **Practise responding to questions with enough detail** if you give short answers or don't respond with enough detail, it's hard for interviewers to understand how you might suit the role you're interviewing for. A good practice is to work with someone to time how long your answers are. Short answers don't give interviewers anything to go off.
- 5. **Practise maintaining strong eye contact** eye contact can be uncomfortable! But it's a sign of confidence and conveys capability. It's good to get comfortable maintaining strong eye contact in interviews.
- 6. **Practise your speech volume, pace and filler words** when we get nervous in job interviews, often we start to talk very fast, speak softly or use too many filler words like "umm", "ahhh" and "like". These can make you seem less competent to your interviewer. To

prepare for job interviews it's good to practise slowing down your responses, speaking at a reasonable volume and reducing filler words.

These are a few key skills and steps you should become more comfortable with to prepare for job interviews. The tricky part for many students is finding ways to practise these skills and get comfortable with the interview jitters. But a Brisbane-based startup called Work Window is here to change that with the world's first <u>Job Interview Simulator</u> that enables you to practise all of these skills in Virtual Reality!

## What's the difference between a reference and a referee?

If you're hunting for work, you've probably put together a resume to hand out to potential employers. One of the most important parts of the hiring process is the employer looking for information about you from other people. This is usually done through references and referees.

But what are references and referees, and what's the difference? Read on to find out.

#### Reference vs referee

A **referee** refers to an actual person – someone you'll put down on your resume who can vouch for your skills and effectiveness.

A **reference** is a written document or statement from a person you've worked for. It usually includes information about the kind of work you undertook, and your skills and abilities.

So someone may be willing to write up a reference for you, but that doesn't necessarily mean you also need to include them as a referee on your resume.

The purpose of references and referees is so employers can cross-check any information you've put on your resume to ensure you're not making anything up.

The benefit of references is that once you have one, you can use it over and over again without needing to worry about it changing. Conversely, the benefit of referees is that they can potentially provide more relevant and up-to-date information.

#### Who can be a referee?

Your referees need to be people who know about your work experience and skills, and are willing to vouch for you in a positive way.

Keep in mind you should never put your parents or friends down as references – employers will usually consider them as biased and unreliable. The best referees are people you know in a professional capacity, such as your employer. If you've never had a job before, you can include people like teachers, mentors or coaches instead.

If you're going to add someone as a referee to your resume, make sure you let them know in advance. Not only is it the polite thing to do, it also means they can be prepared in case a potential employer calls them for information.

Ensure your referee details are always kept up to date – if an employer can't get in touch with your referees, this might affect your application.

#### Who can I get a reference from?

If you'd like to add some references to your resume, they don't just need to come from people you've been employed by.

If you're undertaking work experience, it's a good idea to ask if you can get a reference at the end of your placement. Or if you do any sort of volunteer work, this is great to get a reference for too.

If you have no work experience (either paid or unpaid), you can also ask for what's known as a 'character reference'. Obviously this won't include any details of your work, but can tell a potential employer more about the type of person you are.

References are most credible if they're written or typed on a company letterhead, and also signed by the person who wrote the reference. Keep in mind that employers might contact the business or person you've received a reference from to make sure it's legit.

## **HELP** loans explained

For most school leavers, it's unlikely you'll have access to large sums of money, even if you have been working and saving hard. Your parents or carers might not be able to assist you either. But don't be discouraged – there are options to help you out financially.

If you do choose to go on to study at uni, college or TAFE, and you're wondering how you'll be able to cover the tuition fees and living expenses, we're here to help.

In this blog, we'll be focusing on HELP loans.

#### **Commonwealth Supported Places**

Almost every university in Australia offers undergraduate students <u>Commonwealth Support Places</u> (CSP).

If you're awarded a CSP, it means that the government will cover the majority of your fees. But not all, so you will still have to pay a certain amount.

The amount you'll have to pay is called your <u>student contribution</u>. This amount varies depending on the university and the course you enrol in, and can change every year. You can find the latest amounts on the Study Assist website <u>here</u>.

#### You can apply for a HECS-HELP loan to cover your student contribution costs

You'll either have to pay your student contribution fees upfront...or you can apply for a <u>HECS-HELP</u> loan.

Because it is a loan, unfortunately that means you'll have to repay the money. But you're not obligated to make any repayments until you're earning over a certain salary.

The amount you'll have to earn before you have to start repaying your loan is set by the <u>Australian Tax Office (ATO)</u> and changes each year. So make sure to check with them so you know when you need to start making repayments.

As a guide, the 2022-2023 repayment threshold is \$48,361 per year – so if you're earning below that amount, you won't have to start making repayments.

To apply for HECS-HELP you'll need a <u>tax file number</u> (TFN). You'll then need to fill out a *Request for Commonwealth support and HECS-HELP* form, supplied by your university or other provider. Make sure you submit the form before the <u>census date</u>, or you might have to pay your fees upfront. If you're unsure about the process or need assistance, make sure to contact your university or provider, and they can help walk you through the process.

#### For students who'll have to pay full fees, there's FEE-HELP loans

If you are awarded a university place where you'll have to pay full fees, don't stress.

You can apply for a government <u>FEE-HELP</u> loan to help you out. The money can only be used towards tuition fees, not other expenses like accommodation or books etc.

To apply for a FEE-HELP loan, you'll need a tax file number (TFN) and you'll need to submit a *Request* for FEE-HELP loan form to your course provider. Once again, ensure you fully complete it and submit it before the cut-off date.

#### Other HELP that could be an option for you

If your course provider charges you a <u>student services and amenities fee</u>, you can apply for an <u>SA-HELP</u> loan to help you cover those costs.

**Note:** the maximum you can be charged in 2022 is \$315 – it may change in 2023 and subsequent years.

If you're enrolled in a CSP and want to complete some of your studies overseas, you can apply for OS-HELP loan to go towards airfares, accommodation or other travel costs.

#### There's HELP for vocational studies too

<u>VET Student Loans</u> (VSL) could cover some of your tuition fees if you'd like to study a Diploma-level qualification or above.

If you're applying for a Certificate IV or lower level qualification, then you won't be eligible for a VSL, but you can always ask your provider about other finance options.

#### The HELP loan limit available to you is significant

In 2022, the HELP loan limit is \$109,206. If you apply to study medicine, dentistry or veterinary science, or eligible aviation courses, your HELP loan limit goes up to \$156,847.

This is the maximum amount of money you can borrow from the government, and **includes all** of FEE-HELP, HECS-HELP and VSL combined. You don't have to borrow up to the limit and it's worth remembering that whatever you borrow, you'll ultimately be paying back.

The amount of money you have borrowed and therefore amount of money left available for you to borrow is called your **HELP balance**.

You can keep an eye on your balance at <u>myHELPbalance</u>. You'll need to know your <u>CHESSN</u> (Commonwealth Higher Education Student Support Number) to log in.

#### The HELP balance is renewable

You can start making voluntary repayments at any time, and the money will be credited to your account. This increases the amount available in your HELP balance and could make you eligible to take out further loans.

For example, if you have borrowed up to the HELP loan limit, but you work part time during your studies or get a holiday job, choosing to voluntarily repay \$6,000 off your loans could mean you can access further study.

#### You'll need to do some further research

Before you plan your future studies on the basis of what you've read here, you'll need to find out a few things:

- Are you eligible for these loans?
- What are the requirements to ensure you remain eligible throughout your course? For example, for FEE-HELP you may have to obtain a minimum pass rate each year of your studies or your loan could be suspended.
- Are there any additional fees and costs involved?
- What are your responsibilities after you've graduated?
- How and <u>when</u> you should start making <u>compulsory repayments</u>, or how to go about making <u>voluntary repayments</u>.

## There are other options to help you pay your way too

If a HELP loan could help you cover the cost of your tuition fees, that's one hurdle out of the way. But it's not your only option.

Services Australia also provides financial assistance to students through <u>Youth Allowance</u>, <u>Austudy</u> and <u>ABSTUDY</u>.

You can also consider other things like scholarships, bursaries and grants to help you cover additional costs, including accommodation, books, living expenses and travel.

You can find heaps of scholarships currently open for applications in the <u>Study Work Grow</u> <u>scholarship database</u>.

#### How to become an Anaesthetist

Anaesthetists are responsible for administering general or local anaesthesia to a patient for a variety of reasons, including undergoing surgery, for diagnostic procedures, or for pain relief. They also monitor patients during the procedure in case of an adverse reaction.

If you're kind and dedicated, want work that is rewarding, and are prepared to take on the responsibility of the role, becoming an Anaesthetist could be ideal for you.

#### About you:

- Fantastic problem solver
- Excellent communicator

## The job:

- Examining patients pre-procedure to determine appropriate sedation methods

- Monitoring patients' recovery post-procedure

labourmarketinsights.gov.au). Demand is spread evenly across Australia, with extra demand in regional and rural areas. Most Anaesthetists work in the Health Care and Social Assistance industry.

#### How to become an Anaesthetist in Australia

To become an Anaesthetist in Australia takes many years of hard work and training. You will first need to complete a Medical degree, followed by internship, residency and fellowship.

- Step 1 Complete Year 12 with a focus on English, Maths and Sciences.
- Step 2 Complete a Medical program at university.
- Step 3 After graduation, complete 2 years of general hospital experience.
- Step 4 Apply to become a trainee with the <u>Australian and New Zealand College of Anaesthetists</u> (ANZCA), and complete 5 years of training.
- Step 5 Apply for specialist medical registration with <a href="Ahpra">Ahpra</a> and start working as fully qualified Anaesthetist.

Step 6 – Undertake mandatory continuing professional development (CPD) throughout your career and renew your registration annually.

#### What do Anaesthetists do?

Anaesthetists prepare patients to undergo surgery and other procedures by administering anaesthetics and sedatives.

## Which industries employ Anaesthetists?

Anaesthetists are mostly employed in the Health Care and Social Assistance industry.

#### What options are there for career progression?

There are many pathways you can take as an Anaesthetist, working in general surgery, perioperative medicine, providing pain relief to chronic sufferers, or as a rural specialist working in the farthest reaches of the country.

## Do I need to go to university to become an Anaesthetist?

Yes, you will need to complete a medical degree and undergo around seven years of additional training before you can work as an Anaesthetist.

#### Where do Anaesthetists work?

Anaesthetists are employed in both public and private hospitals, private clinics, day hospitals, and in specialist clinics.

#### What are 3 things I can do right now to help me become an Anaesthetist?

If you're in high school and you'd like to find out if a career as an Anaesthetist is right for you, here's a few things you could do right now:

- 1. Start looking at medical programs in Australia and make sure you're on track to meet any entrance requirements. Consider whether you're willing to complete the long training requirements.
- 2. See if you can find work experience in medicine or health. This will help you see if you might enjoy the work, and can help you start building important contacts for the future.
- 3. Talk to an Anaesthetist to see what a day in their life is like. If you don't know anyone, see if you can watch videos or documentaries about a career in health.
