Instrumental Music Program

Instrumental music lessons are offered from Class 3 onwards. The study of a stringed instrument (violin, viola or cello) and participation in Orchestra is compulsory for students in the Steiner Program. Senior students in Class 6 have the option of commencing non-string music lessons. The non-strings instruments on offer include voice, drums, guitar, piano, woodwind (flute, clarinet, saxophone) and brass (trumpet, trombone).

Financial Support for Families

Collingwood College understands that some families may experience financial difficulty and offers a range of support options, including:

Payment Methods

Several payment methods are available including BPay, Compass, in person or by phone. Payment plans for extra-curricular items and activities can be established with accounts receivable Elizabeth Keily at the school. Further details of payment methods and options are below.

Option A	BPay – This number is located on the bottom of your family statement. If you cannot locate this number, please contact the office. Please email the school at collingwood.co@education.vic.gov.au at the same time of payment to let us know what you are paying for.
Option B	Compass – This form of payment is done through the Compass portal
Option C	In-person or by phone – Cash, cheque, credit card
Option D	Direct Deposit – Funds may be credited to our school bank account. It is essential that you include your code (same as your compass ID) or Student Name and a brief description of what the payment is for e.g., "BAR0002 Voluntary Contributions," or "WAR0774 Year 5 Camp." FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
