### TUITION FEE

These are charged on a per student basis with discounted rates applicable to families with more than one student attending the College in the same year:

- 10% discount on second student
- 20% discount on third and subsequent students

There are no family discounts applicable to additional program fees or enrolment fees.

### CAPITAL LEVY

The Capital Levy is charged on a per family basis and is designed to fund the increasing costs of both improving and maintaining our College resources. This is a compulsory levy and is not tax deductible.

## WHAT IS NOT INCLUDED

The following items are payable in addition to tuition fees:

- Booklist items
- Uniform
- TAFE--VET subjects external studies
- Edrolo charges for VCE subjects
- Private Music and Band Tuition and Instrument Hire
- Library Charges – replacement of lost items
- Year 12 Ball and Graduation Dinner
- Optional Programs and Trips

## OPTIONAL PROGRAMS AND TRIPS

These programs and trips (eg Duke of Edinburgh, Central Australia, World Challenge, East Timor, Italy, etc) are only available to students whose fee payments are up to date. No student will be allowed to participate in these optional activities while school fees remain outstanding or fee relief has been given.

## CAMP, SPORT AND EXCURSION FUND

Parents who hold a Pensioner/Health Care Card, regardless of the age of the student, can apply for the Government *Camp, Sport and Excursion Fund*.

We encourage all parents and carers who are eligible to apply for this subsidy, as each student will receive \$225.00. This amount is deducted from the fees.

## NOTICE OF WITHDRAWAL OF ENROLMENT

Notification of withdrawal must be made **in writing to the Principal, giving at least one full term's notice**. A term's fees will be charged in lieu of this notice. Fee refunds or rebates will only be calculated once all required documentation has been provided to the College. There will be no refund available for Capital Levy and VET Subject Levies.

## OVERDUE ACCOUNTS

Overdue accounts will be followed up and may ultimately be transferred to a collection agency unless an alternate payment arrangement is confirmed with the Fees Accountant. Any costs incurred will be added to the Fee Accounts.
