

ST MARY'S SCHOOL, MOOROOPNA School Fees & Levies 2025

Dear Family,

Set out below is the school fee and levy structure for 2025. Please note that the School Council sometimes alter fees and that these figures are subject to change.

Family Fees

School Fee Per family \$1255

Sandhurst Diocesan Land Fund Fee Per family: \$50

Maintenance Fee Per family \$100

Student Fees

Capital Levy Per student \$105

Prep to Year 6 Levy Per student \$320 (Payable by Friday 14th March 2025)

The levy covers classroom supplies and special programs.

Technology Fee Per student

Grade 5/6: \$210. Grade P-4: \$165

Excursions/Camp Levy Per Student

Grade 5 & 6 \$610 (\$505 Camp + \$105 Excursions) Grade 3 & 4 \$405 (\$300 Camp + \$105 Excursions)

Grade P/1/2 \$170 (Excursions)

Number of Children per Family	Annual Fee & Levy Combined	Annual Fee & Levy + Technology Levy + Camp/Excursion (as applicable to grade level)
One Child	\$1,830	
Two Children	\$2255	
Three or more Children.	\$2255	

Note: 3rd Child Discount: Student Levy discount for 3 or more children.
Student levies do not apply when more than 2 children enrolled. E.g. Third child enrolled does not pay Prep-6 Levy or Capital Levy. This discount (\$425) will automatically be applied to your statement.

Fees & Levies Payment Options 2025

Direct Debit

The school offers a Weekly, fortnightly or monthly Direct Debit facility. We strongly recommend this option of payment. If you wish to use this facility please indicate this option in your enrolment form.

• If you have indicated "Yes" to using the **Direct Debit facility**, **please fill in the attached authority** indicating your preference of **weekly**, **fortnightly** or **monthly payments** and calculate your amount by dividing your annual fees by 40 for weekly, 20 for fortnight & 10 for monthly payments.

A confirmation letter & schedule will be sent to you indicating the Direct Debit amount and the date of 1st deduction.

PLEASE NOTE – A new Authority Form is required each year for this to continue, Direct Debits are not automatically recommenced.

Centrepay

The school is registered to receive fees via **Centrepay**. Information and application form can be found in your enrolment pack, fill in the relevant information and return directly to the School Office. Applications or changes can also be made via your MyGov account directly. Please contact the Office or Centrelink if you require further information.

Direct Deposit
