iPad Loan Agreement – 20.....

The school provided iPad will be for the student's personal use, to support student learning. Applications will be assigned to your child's iPad that supports a range of programs including English & Mathematics such as Yr 6-9 Maths Pathways program.

ELIGIBILITY

- The iPad is available for students who have paid the full Curriculum Charges. If you are experiencing financial hardship, you can arrange a payment plan for the Curriculum Charges with the Principal or Business/Finance Manager.
- At the end of the three-year loan agreement, students have the options to either return the school provided iPad or pay \$10 to buy out the students' pre-loved iPad.
- They can then commence another loan agreement for a new school provided iPad. School apps will be removed from the student's old iPad and transferred to the new iPad.

In the event of any missed Curriculum Charges payments the iPad will be collected and withheld until payments are made.

RESPONSIBILITIES

- iPads must be brought to school fully charged every day. Students will not be able to charge their device at school. The iPad **must** remain in the provided cover at all times.
- The School has acquired licenses to issue applications and reserves the right to withdraw applications from the loaned iPad at any time, including when a student leaves the school.
- Students/families are not permitted to log into the iTunes/App Store and/or download their own apps, music or other media onto school iPads. Students/families must not remove the management profile from the school iPad or the student will forfeit the iPad for a minimum of one week while it is fully wiped and reconfigured by the IT Team. Students in the Middle Years will be encouraged to protect the work on their iPad through a passcode screen lock.
- The School bears no responsibility for any loss of data at any time.
- The Lakes South Morang P-9 School reserves the right to suspend the student's iPad use or terminate this agreement. If the student is absent for a period greater than 6 weeks or for overseas travel, the student's iPad will need to be returned to school.
- The iPad, charger and school-purchased cover remain the property of The Lakes South Morang P-9 School and must be maintained in good working order until the end of a three-year period, and then returned to the school, if not purchased.
- Pre-loved iPads, charger & cover can be purchased by the parent/guardian at the end of the three-year loan period, providing Curriculum Charges have been paid in full for the previous three years.

USAGE

- ICT User Agreement - the student must review, sign at the start of each year and abide by the Information Technology Acceptable Use Policy at all times. The apps/services available to each year level will be selected on an age-appropriate basis, and used in accordance with the publisher's terms of use.

DAMAGE/LOSS

- There is no insurance available to cover repair/replacement cost. Families are required to arrange repairs to any damaged iPads or chargers. Lost or misplaced iPads must be reported to your child's home group teacher so that IT staff can limit usage. Any replacements must be purchased through the school.
