### **Bond Indigenous Scholarship**

Value: Up to 100% tuition remission

Open/Closing Dates: April 1, 2021 – September 5, 2021

Through the generous support of corporate sponsors, and from other funds made available to the University, Bond offers a number of scholarships to Indigenous Australians.

These scholarships, valued up to 50% of tuition fees for any single undergraduate degree (excluding the Medical Program) or 100% tuition for any diploma program, are awarded to Aboriginal or Torres Strait Islander students who have demonstrated extracurricular involvement, leadership potential and academic achievements.

Eligibility:

- This scholarship is available to new commencing students at Bond University in the following year, January semester.
- Available to Australian citizens who are of Aboriginal or Torres Strait Islander descent (as defined by ABSTUDY).
- Applicants must have successfully completed, or be currently completing Year 12 at an Australian High School.
- Applicants must meet the prerequisites and the admissions entry standards for their chosen program.

### **Bond Transformer Scholarship**

Value: Up to 50% tuition remission

Open/Closing Dates: April 1, 2021 – September 5, 2021

Two Transformer Scholarships are awarded annually to students beginning their Bachelor's degree or Master's degree study at Bond University in the following year, January semester. Transformer Scholarships offer up to 50% tuition remission for any single undergraduate Bachelor's degree or postgraduate Master's degree program (excluding the Bond Medical Program) and are awarded to students who have high potential to affect real change through participation in the Transformer program.

- Extensive involvement in extracurricular activities; and
- Applicants must also meet the entry requirements for their chosen program of study.

### 4 tips to get smart about money

By the time you leave high school and often before, it's important to learn how to manage your money and make decisions that make financial sense for your situation.

If you can budget, manage your money, make wise decisions about your spending and saving habits, then you're well on your way to being financially literate.

#### **Here are our 4 top tips:**

##### **1. Set up a bank account**

Even if you don't have much money coming in, it's a great idea to have your own bank account and debit card so that you're ready when you do start earning.

You'll also have somewhere safe to put pocket money and monetary gifts that you might receive, instead of risking it dropping out of your pocket at school, going through the washing machine, or tempting you to buy something you don't really need.

##### **2. Find a job**

Once you start earning your own money, you'll appreciate it's value much more.

It could encourage you to make better decisions about what you buy, when you know how long it took you to earn it.

##### **3. Do a budgeting challenge**

You may not have seen [Teenage Boss](#), it's a show where teens in a household are allowed to take over the family budget for a month.

Perhaps you could do something similar at home?

Speak to your parents and work out:

- Your household monthly income

- Household monthly outgoings (that's *all* the bills from food and electricity, to rates and school shoes)
- Decide on a target figure that you'd like to save
- Work on how you can implement changes to reach your target

You could write meal plans and cook in bulk, find free activities to do in your spare time, or recycle all your cans and bottles for extra cash.

#### 4. Start saving

You could just start saving today; it's simple. Figure out how much money you already have, or how much you get every week and commit to setting aside a percentage of that.

Make sure your money isn't too easy to get to, otherwise you could be more tempted to dip into it.

When you set up your bank account, talk to the bank about a savings plan as well. They can give you lots of ideas about the best way to save for you, including where your savings will get the most interest.

The money you put away could help you buy a car, go towards uni, or pay for your gap year.

#### [Gap Year Programs and COVID-19](#)

Thinking about planning a Gap Year but unsure about how your plans may be interrupted? Lots of Gap Year providers are aware that students are nervous about putting down a deposit but also anxious to make plans for late 2021 and 2022, but they are keen to reassure students that they're still planning programs for destinations, including the UK and New Zealand. In fact, some programs have already sent 'gappies' to New Zealand this year. [From WEP:](#)

"WEP remains hopeful that programs departing in late 2021 will continue as planned. Our overseas partner organisations, coordinators and host families around the world are looking forward to welcoming the next generation of WEP students."

Some even report that student applications are returning to pre-pandemic levels, and have advised that students should seriously consider lodging their applications so that they don't miss out. [Letzlive suggest the following for Australian students:](#)

"Our advice to prospective applicants for July (for our New Zealand intake) and September (for our UK intake) 2021, and again for January 2022 (all destinations), is to lodge your application prior to the extended May 31st closing date."

Many other programs are still accepting applications, and in just about all cases they'll offer a refund or an alternate trip if yours doesn't go ahead. Just **make 110% sure before you book** that they will definitely refund your money if something goes wrong. If your tour goes ahead and you get ill with COVID-19 while you're away, your program's insurance should cover any medical costs.



More than ever, it's essential that you check the fine print before you agree to anything or hand over any money – remember to choose a reputable company and if you are at all concerned then don't book, or you may never see your money again.

### **How to become a Park Ranger**

***Be a protector – of ecosystems, wildlife, and people***

#### **What do Park Rangers do?**

Park Rangers are part of a team who work on the ground to monitor, preserve, and maintain State or national parks, scenic areas, historic sites, nature reserves, recreation areas or conservation reserves. They are guided by policies and laws and act to enforce those where necessary.

If you are passionate about conservation and education, love being outdoors and are great at communicating, this could be an ideal career to explore further.

#### **About you:**

- Excellent communication and leadership skills
- Physically fit, practical and resilient
- Passionate and well informed
- Flexible approach to work
- Great customer service and conflict resolution
- Enjoy outdoors work in all weather
- Organisational, project management and teamwork skills

#### **The job:**

- Patrol, monitor, and assess natural and recreational areas
- Identify and eradicate invasive and pest species
- Identify and protect endangered species
- Promote and maintain the parks assets
- Work to control fire, flood and other damage
- Build relationships and work co-operatively with indigenous owners and communities
- Grant permits, enforce laws and assist with research and volunteer projects
- Maintain and develop visitor facilities, boundaries and signage
- Respond to emergency situations
- Deliver information, reports, and education to visitors, schools and stakeholders

## Lifestyle Impact: Medium

- Part Time opportunities: Low – only 19% of Park Rangers work part-time (source: joboutlook.gov.au).
- Average hours for full-time workers: 41 hours a week, which is average (source: joboutlook.gov.au).
- Park Rangers' salary (average) \$80,000\* per year (Source: com.au). \*Salaries vary depending on your skills and experience.
- Future career growth: Strong (Source: joboutlook.gov.au).
- You'll likely be working weekends, holidays and other maybe even sometimes at night, and you'll need to be confident living and working in remote areas.

## Park Rangers are most in demand in these locations:

This is a small industry, employing only 2,500 workers in 2016 although numbers are increasing annually (source: joboutlook.com.au). There are opportunities available for Park Rangers across Australia and most of the roles with Government Agencies.

Working as a Park Ranger you'll need to be active in the area you're employed which may mean living away from home or relocating, this may be to remote and regional areas.

## How to become a Park Ranger in Australia

You can work as a Park Ranger without any formal qualifications Park Ranger in Australia, but a VET or other qualification in land or park management for example may improve your employment prospects.

**Step 1** – Complete your high school certificate and consider taking subjects such as English, Biology, Chemistry, Geography, and History.

**Step 2** – Consider studying a relevant qualification to boost your skills and employability. You could study a course such as a [Certificate III in Conservation and Ecosystem Management](#).

**Step 3** – Volunteer to work on projects in park settings, get work experience with Park Rangers, or undertake your own projects locally. Tour guiding, gardening and landscaping, zoo keeping, seasonal firefighting and tourist information centre work could also provide you with valuable skills.

**Step 4** – If you're really passionate consider a university degree such as [Bachelor of Environmental Management](#),  
Or [Bachelor of Environmental Science \(Wildlife and Conservation Biology\)](#)

**Step 5** – Once you have some experience under your belt, you can move into higher positions such as Ranger in Charge or more policy and planning positions within the organisation.
