PAYMENT OPTIONS

FEE RELIEF OPTIONS:

HEALTHCARE CARD HOLDER

Families who are eligible for or hold a current Pension or Healthcare card may qualify for further fee assistance and are asked to contact the office.

CAMPS, SPORTS & EXCURSION FUND

Families who hold a current Pension or Healthcare Card are asked to apply for this funding as it helps the school to cover the costs of travel and sporting activities that occur during the year, not just the scheduled camps for Grades 3 to 6. If you have applied in past years your student will remain funded while your card is active. Any new students will need to be included in a new application. Please see the school office for a form.

The CSEF system only allows one application per student. Parents/carers in shared custody situations (who both hold a concession card) must decide beforehand who applies for the CSEF at the school on behalf of the relevant student. The CSEF is for the benefit of the parent/carer who is in receipt of the CSEF. Schools are not required to arbitrate this decision.

SCHOOL INITIATED FEE RELIEF

As directed by the Catholic Education Office, in 2026, our school will be offering additional fee relief to those families who meet our set criteria. The relief will essentially reduce your total fees to \$540 per student (after the CSEF has been deducted). Certain conditions are to be met to qualify. Please contact our office for more information.

If you feel you do not qualify for any of the relief options as mentioned above but may be experiencing financial difficulty, please make contact with myself to discuss this.
