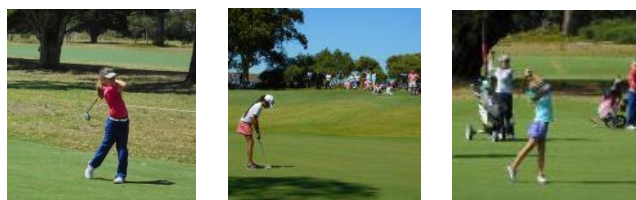

Open to girls, 10-17 years of age (as on the day) who do not hold an official handicap. The field is limited to 20 entrants
- Prizes: Category 1 – Top qualifier, all finalists and Winner of the shoot-out

## **1. COMPETITION PROCEDURES**

- 1.1** The **category 1 event** is scheduled to be played over 6-holes stableford with finals shootout. The **category 2 event** scheduled to be played over 6-holes modified stroke Ambrose.
- 1.2** Following the 6-holes stableford qualifying, the leading 4 players plus ties will qualify for the finals shootout in Category 1.
- 1.3** Entries will be accepted on an as received basis until the field capacity is reached. The field for category 1 is restricted to the first 40 entrants, and the field for category 2 is limited to the first 20 entrants.
- 1.4** No caddies please. (See 5 below)

## **2. CATEGORY 1 ELIGIBILITY**

- 2.1** Eligible players are female amateurs who are aged under 18-years old as at the day of the competition and whose GA Handicap on the day of the event is over 16.2.

## **2.2 CATEGORY 2 ELIGIBILITY**

- Eligible players are female amateurs who are aged 10-17 years old as at the day of the competition and do not hold a GA Handicap.
- 2.3** Younger players may be accepted at the at the discretion of the Tournament Committee.

## **3. ENTRIES**

- 3.1** Entry fee must be paid at the time of entry.
- 3.2** The Tournament Committee shall have the right to refuse the entry of any person without being required to give any reason for such refusal.
- 3.3** Entries shall be made online at [www.golf.org.au/victoria](http://www.golf.org.au/victoria)
- 3.4** Entries close 5:00pm on Wednesday 16 January, earlier if field capacity is reached.

## **4. TROPHIES**

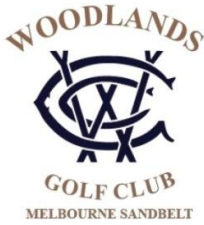
- 4.1 CATEGORY 1** The player who wins the final shootout will be the winner named on the perpetual trophy and shall receive a prize. All other finalists shall also receive a prize.
- 4.2 CATEGORY 2** The team with the lowest stroke score shall receive prizes.
- 4.3** Prizes for NTP's, Longest drives, Straightest Drives.
- 4.4** In case of a tie the Golf Australia count back method will be used to separate all trophies in Category 2. A shootout will be used to separate any ties in Category 1.
- 5.** Woodlands Golf Club will appoint a qualified adult to walk with each group to assist with scoring, Rules & pace of play. Hence caddies are not allowed.

## **6. TOURNAMENT COMMITTEE**

The Tournament Committee shall consist of representatives of the Woodlands Golf Club. In the absence of the full Tournament Committee, present members of the committee at any time may give a decision and any decision shall be deemed the decision of the full Tournament Committee.
