



Equity stream

Schools Recommendation Scheme

Created to support students who are impacted by a range of educational disadvantages as part of UTS' commitment to supporting students through an equitable admission process. The Equity Stream is offered under the Schools Recommendation Scheme.

Eligibility criteria

- Current Year 12 student and have applied for undergraduate study through UAC
- Australian citizen, a New Zealand citizen, a permanent resident of Australia (including a holder of an Australian permanent resident humanitarian visa)
- Meet the eligibility for inpUTS (educational access scheme) under one of the following types:
 - Socio-economic disadvantage (AG01)
 - School environment (S01C only)
 - Financial hardship (F01A, F01B, F01D, F01K or F01S)
- School principal or career adviser should rate your Schools Recommendation Scheme application (SRS)
- Include a UTS preference within your UAC application for the SRS November offer round.
- Achieve a minimum ATAR of 69 (80 for Law)

How to apply

Submit your Educational Access Scheme and Schools Recommendation Scheme application through UAC before the closing dates.

Note: For socio-economic disadvantage (AG01) and School environment (S01C only) you do not need to submit an Educational Access Scheme application as UAC automatically generates an electronic application for you. All financial disadvantage claims must be submitted to UAC before the closing date.

Offers

All Equity Stream offers will be made to your highest eligible UTS preference. Both your Year 11 studies and the Selection Rank (Year 12 ATAR + adjustment points) may be considered when assessing your application for an offer.

Unconditional offers – Limited number of unconditional (guaranteed) offers will be made based on Year 11 studies in November 2021.

Conditional offers – will be made in November 2021. These offers will become unconditional following the ATAR release and meeting the minimum ATAR requirement, and any other conditions of entry for your preferred course. These offers will be released in the December Round 2.

Access stream

Schools Recommendation Scheme

UTS is committed to supporting students through an equitable admission process. Launched in 2020 in recognition of the disruption caused by COVID-19, the Access Stream under the Schools Recommendation Scheme has been extended for the Autumn 2022 (session 1) intake.

Eligibility criteria

- Current Year 12 student and have applied for undergraduate study through UAC
- Australian citizen, a New Zealand citizen, a permanent resident of Australia (including a holder of an Australian permanent resident humanitarian visa)
- School principal or career adviser should rate your Schools Recommendation Scheme application (SRS)
- Include a UTS preference within your UAC application before the close of preference deadline for December Round 2 offers
- Achieve a minimum ATAR of 69 (80 for Law)



How to apply

Submit your Schools Recommendation Scheme application through UAC before the closing date in September 2021.

Offers

Access Stream offers will be made to your highest eligible UTS preference. Offers will be made in the December Round 2.

Both your Year 11 studies and the Selection Rank (Year 12 ATAR + adjustment points) may be considered when assessing your application for an offer.
