Did you know... Child Care Subsidy offers 2 types of payments?



Child Care Subsidy (CCS)

The amount of CCS you are entitled to depends on:

- Your family's combined income
- The type of child care service you use
- Your child's age
- The hours of recognised activities you and your

Example:

A family eligible for 75% CCS will only pay 25% of the total session fee.

If a 10-hour session costs \$100, the family will only have to pay \$25, while the rest is covered by CCS. That's only **\$2.50 an hour!**



Additional Child Care Subsidy (ACCS)

On top of CCS, you can be entitled to ACCS if you are one of the following:

- A Grandparent
- Transitioning from income support payments to work
- Experiencing temporary financial hardship

What to know about your VillageOSHC Holiday Program!

5 things VillageOSHC always provides:

- 1. Healthy breakfast (served until 8:30 AM)
- 2. Delicious and healthy afternoon tea
- 3. Fresh drinking water all day
- 4. Sunscreen
- 5. A Low Cost, Guilt Free, Super Fun Holiday Program

What should I pack for my child?

- **1.** A healthy, nut-free morning snack and lunch just like a regular school day (no microwavables)
- 2. A labeled, refillable water bottle
- Weather-suitable clothing closed shoes, no singlets, jacket/coat for cold weather
- 4. A hat for sunny days
- 5. An art smock and old clothing if participating messy activities
- A Medical Action Plan and Medication if applicable (digital copies must be uploaded to LookedAfter™)

Please leave items such as electronic devices, money and personal valuables at home. We do not accept responsibility for damaged or lost items. We are a device-free zone!

Label all items with your child's name!

Please remember

If enrolled with VillageOSHC, you can attend any VillageOSHC service anywhere in Australia.

You do not need to regularly attend the school itself to attend a VillageOSHC Holiday Program.

Excursion days

Please check drop-off and pick-up times on excursion days as this impacts bus departure and arrival back at the service. **Drop-off and pick-up times are indicative only.** To be sure, contact your VillageOSHC service directly.

If you are booking a session in **LookedAfter™**, follow the usual process. You'll find bus times under **Service**.

If you've already booked, log in to your **LookedAfter™** account, go to your **Booking Calendar** and click on the excursion day to see excursion information.

Activities

Sometimes changes are out of our hands. Activities and times may change due to unforeseen circumstances (weather events, etc).

If an activity is unable to run, we will supply an alternative activity for your children to enjoy.

Medical Action Plans & Custody Orders

All children diagnosed with medical conditions require a Medical Action Plan to be uploaded to your LookedAfter™ account under Conditions.

Conditions include allergies, intolerances, asthma, epilepsy, and anaphylaxis, etc.

Children with a custody order must have all custody order documentation uploaded to your LookedAfter™ account under Conditions.

Please supply the following if applicable:

- A complete Medical Action Plan
- Required medication
- Child custody order documentation

Please note: it is required by law under the Education & Care Services National Regulations and VillageOSHC's Terms and Conditions that you supply the above.

We may refuse to accept care of the child if the appropriate documentation or medication is not supplied (which may incur fees). This is for child safety and wellbeing reasons.
