Curriculum Contributions

Book Packs

Teesdale Primary School book pack purchased through Winc Education provides parents with high quality items at a lower than catalogue price, according to year levels. Your child may not require every item, but because the book packs are supplied direct to school as standard issue, it is cheaper to leave all items on the list. Parents may choose to provide or purchase items themselves. If you choose to do this, please consult with the school so that your child has the right items.

Please advise the school office by Friday 28th November 2025 if you do NOT wish the school to order a 2026 Book Pack for your child.

DIBELS (Dynamic Indicators of Basic Early Literacy Skills)

The cost is \$15.00 per student for DIBELS for 2026.

DIBELS is a tool which streamlines the assessment of reading. This assessment tool is designed to shorten the time it takes to assess each student and will be used regularly to detect risk and monitor the development of early literacy and early reading skills from Foundation to Year 6. One of the many benefits of the DIBELS assessment system is that teachers spend less time assessing students and more time teaching.

Note: DIBELS is subsidised by the Government and at Teesdale Primary School is accessed by all students in all grades. Teachers can assign tasks at appropriate level and target learning to each child's needs.

Refunds

Parent requests for refunds are subject to the discretion of the school and made on a case-by-case basis.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
